AMENDMENTS

(Ryan White HIV/AIDS Program Datasets)  
Background: The ordinance approves a Data Sharing Agreement with Washington State Department of Health (DOH) for access to the Ryan White HIV/AIDS Program (RWHAP) datasets. The Snohomish County Health Department will collect RWHAP data to be entered into the Washington State DOH's Electronic Client Management System which will be used to support and facilitate health interventions. The Health Department will use the RWHAP datasets to monitor health outcomes and adherence to treatment regimens, including tracking trends for public health indicators and preparing reports on specific public health issue. The term of the agreement is from July 1, 2024, through June 30, 2029. At the Public Hearing, the Council may consider amendments to the proposed ordinance.

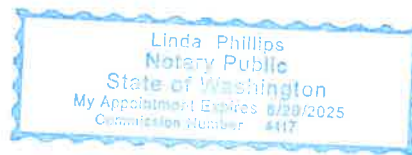
