



PROPOSED ORDINANCE NO. 21-073  
RELATED TO THE 2021 BUDGET; MAKING A  
SUPPLEMENTAL APPROPRIATION FOR RECEIPT OF A  
PORTION OF THE PROCEEDS OF THE 2021 TAX-EXEMPT  
LIMITED TAX GENERAL OBLIGATION BONDS IN PARKS

MEADOWDALE BEACH PARK AND ESTUARY

Section 1. The County Council makes the following findings of fact: a supplemental appropriation in the 2021 budget year is necessary in the Parks Construction Fund 309 in the amount of \$100,000 to pay the costs of issuance of the Bonds allocable to the Project.


