INTERLOCAL AGREEMENT CLFR-118a2

Summary: The ordinance approves the agreement with North County Regional Fire Authority for the County to award Coronavirus Local Fiscal Recovery (CLFR) grant funds under the American Rescue Plan Act. The North County Regional Fire Authority will receive grant funds in the amount of \$500,000 for the purchase of fire training modules. The agreement period is from November 1, 2023 to June 30, 2026.

At the Public Hearing, the Council may consider amendments to the proposed ordinance.
