NOW, THEREFORE, BE IT ORDAINED:
Section 1. Snohomish County Code Section 9.12.055, last amended by Ordinance No.
11-014, on May 25, 2011, is amended to read:
9.12.055 Animal relinquishment fee.
(1) Residents of unincorporated Snohomish County may for a fee ((of \$25.00)) per animal
deliver and relinquish ownership of unwanted dogs or cats owned by them to any animal shelter
providing that service pursuant to a contract with the County. Residents may deliver stray dogs
or cats without payment of a fee to any animal shelter providing that service pursuant to a
contract with the County.
(2) The fee shall be paid directly to the animal shelter by the person relinquishing the animal at
the time of release.
(3) All fees become the property of Snohomish County and shall be transmitted to the county in
the same manner as other fees collected and remitted according to the process specified in the
current shelter services contract.

(4) The fee for relinquishment of an animal shall be set by the director of animal services, subject
to approval by the county council by motion.

### **Background**

Current Snohomish County Code, last amended in 2011, calls for the payment of a \$25 per animal fee for delivery and relinquishing of ownership of unwanted dogs or cats, to be paid directly to the animal shelter. For 2022, the contracted animal shelter for ownership relinquishment charges Snohomish County a fee of \$215 per animal. This ordinance would amend code to allow for annual rate setting by the Director of Animal Services, subject to approval by motion of the County Council.

Ordinance 22-002, relating to animal relinquishment fee; amending section 9.12.055 of Snohomish County Code

**PURPOSE:** To amend the ordinance to recover costs from owner relinquishment of their animals to the contracted shelter under Title 9 SCC.

**BACKGROUND:** SCC 9.12.055 is amended to allow the auditor to set owner relinquishment fees based on costs incurred by the county for these animals. The current relinquishment fee is set by code at \$25 per animal and falls short of the actual cost incurred by the county per animal. In 2022, the contracted shelter charges the county \$215 per animal. There are many resources for residents to rehome dogs/cats and the shelter works with pet owners to find alternatives to depositing their animals at the shelter. The proposed amended ordinance allows the auditor to set the relinquishment fee, subject to approval by council, with the goal of recovering the county's costs for owner relinquishment of their pets to the contracted shelter.
