## SNOHOMISH COUNTY MARINE RESOURCES ADVISORY COMMITTEE

The Snohomish County Marine Resources Advisory Committee (MRC) is authorized by Chapter 2.800 SCC and is one of seven advisory committees participating in the Northwest Straits Marine Conservation Initiative. In 1997, U.S. Senator Patty Murray and U.S. Congressman Jack Metcalf recognized the need to protect the marine waters of Washington State and with that strong bipartisan alliance the Initiative was created by Congress in 1998. The purpose of the MRC is to address local marine issues and recommend remedial actions to the council, executive and, where requested by the council or executive, to other local governmental entities and tribes. When making recommendations the MRC shall be guided by sound science. The MRC is made up of no more than 13 members with balanced representation from individuals with relevant experience or scientific experience representing: a) local governments; b) affected economic interests; c) recreational, conservation or environmental interests; d) local tribal governments; and e) at-large. Terms shall be three years in length. Contact.
