**Subject:** Interlocal Agreement between Snohomish County and the City of Everett

for an Emergency Bridge Housing Facility

Scope: Snohomish County is seeking to enter into an agreement with the City of

Everett for an emergency bridge housing facility. The facility will be located at 3715 and 3719 Smith Avenue, Everett, WA 98201.

Under the terms of the agreement, the County will provide \$4,000,000 in CDMH funds to the City of Everett. The City of Everett will then execute a loan agreement with Everett Gospel Mission. Everett Gospel Mission will acquire property and operate the project. Allowable reimburseable costs include property acquisition, design and permitting, and furniture purchases. The property must be ready for operation no later than December 31, 2026.

The property will have a use restriction covenant that requires that it be used for emergency bridge housing for homeless individuals where behavioral health services are offered. The facility will offer 65 beds of emergency bridge housing capacity and 60 beds for emergency severe weather shelter.

**Duration:** Upon effective date until December 31, 2026, and may be extended until

December 31, 2027.
