## **Consideration**

The Executive's Office requests Council consider approving proposed Motion 22-053 which would approve and authorize an agreement between the county and the Washington State Department of Social and Health Services (DSHS) to implement the MAC/TSOA Implementation Grant<sup>1</sup>.

## **Background**

Section 1115 of the Social Security Act gives authority to the Secretary of Health and Human Services to approve demonstration projects that are found to be likely to assist in promoting the objectives of the Medicaid Program.<sup>2</sup> Washington State, as part of their Medicaid Transformation Project (MTP) has a demonstration project implementing Medicaid Alternative Care (MAC) and Tailored Supports for Older Adults (TSOA). Snohomish County's Human Services Division acts as the Area Agency on Aging, providing these services in Snohomish County.

**Medicaid Alternative Care** is a benefit for individuals who are eligible for Medicaid but not currently accessing Medicaid-funded long term supports and services (LTSS). This benefit provides services to unpaid caregivers to assist them in continuing to provide care while also focusing on their own health and well-being.

**Tailored Supports for Older Adults** establishes a new eligibility category and benefits for individuals at risk of future Medicaid LTSS who do not currently meet Medicaid financial eligibility criteria. This is designed to help individuals avoid or delay impoverishment and the need for Medicaid-funded services.

## **Current Proposal**

*Scope:* Motion 22-053 approves the grant agreement between the county and DSHS for the county to implement the MAC and TSOA demonstration project.

Duration: January 1, 2022 through December 31, 2022

Fiscal Implications: \$1,652,333<sup>3</sup> (\$739,000 in various personnel and operating objects and \$913,333 in Pass through)
