Scope: The proposed agreement is for a turn-key software solution for an

electronic reservation management system, to be used by the Department of Natural Resources and Conservation. This software will allow for the public to reserve facilities such as yurts, shelters, campsites, and conference rooms. The software will allow the County to modify reservations, cancel reservations, refund reservations, discount, set and adjust business rules, create, and adjust user accounts, set and adjust fees and taxes, block dates, add or modify

sites, locations, room rentals, ball fields and centers.

<u>Duration:</u> The Agreement shall be effective upon execution and shall terminate

five (5) years from the execution. The Agreement may be extended in

three-year terms.

<u>Authority Granted:</u> Approve and authorize the County Executive to execute the Software as a Service (SaaS) Agreement for a reservation management system, and associated amendments between Snohomish County and OQPoint, LLC., SCC 3.04.140(8).

Background: The County published RFP-23-009TB-S to solicit proposals for a new electronic reservation management system. OQPoint's Camava system was selected by the Snohomish County evaluation committee as submitting the highest-ranking proposal to provide the reservation management system for the Counties wide variety of reservable sites and activities available to the public.

The cost for services, including initial implementation, licenses and maintenance is not to exceed \$26`,913.50, plus applicable sales tax.

<u>Action Requested:</u> For Council to move the motion to GLS on September 4, 2024, for consideration, as the contract is requested to be expedited.
