## **Consideration:**

The proposed motion would approve and authorize the County Executive to execute Amendment 11 to the Master Contract for an Automated Vehicle Location System with CalAmp Radio Satellite Integrators, Inc., under SCC 3.04.190.

## **Background:**

In 2012 the Snohomish County Council approved a contract with Radio Satellite Integrators, Inc. (renamed CalAmp Radio Satellite Integrators, Inc. within Amendment No. 7) for an automated vehicle location (AVL) and mobile data system for an original 178 Public Works vehicles, which has grown to include 387 County vehicles. The AVL system provides the County with the tools for faster and more efficient dispatching, along with real-time and historical data that can be used for a variety of administrative tasks and analysis.

CalAmp was selected using applicable Federal, State and County policies and practices. To date there have been 10 amendments to the Master Contract (outlined below) with amendment 10 having been approved last year while contract was recompeted. Due to staffing changes in OpEx, the contract has not yet been recompeted and an additional extension has been requested. The current agreement term is set to expire on October 28, 2023.

## **Current Proposal:**

Scope: Approval and execution of Amendment No. 11 will extend the agreement for an additional one-year term while AVL services are recompeted.

Duration: Amendment 11 of the Master Agreement extends the existing contract for one year after date of execution.
