Summary: The motion reappoints Layla Bush to the Snohomish County Planning Commission as the Council District 3 representative. Planning Commissioners are volunteers who are appointed by the County Council. They serve four-year terms and can be reappointed for up to three full terms. Layla Bush is nominated to a first full term which will expire on July 1, 2030.

At the Public Hearing, the Council may consider alternatives/amendments to the proposed motion.
