<u>Authority Granted:</u> Approve and authorize the County Executive to execute the Professional Services Agreement for medical imaging software, and associated amendments between Snohomish County and CMX Medical Imaging, under SCC 3.04.140(8).

Background: Snohomish County published RFP-23-040JM-C soliciting proposals for a new commercial off-the-shelf web-based, zero footprint, radiology software platform. CMX Medical Imaging in partnership with Konica Minolta Medical was selected by the Snohomish County evaluation committee as submitting the highest-ranking proposal to provide the Konica Minolta Symmetry PACS product subscription services. CMX was selected through established Federal, State and County policies and practices. The proposed agreement was negotiated.
