**Background:** On May 18, 2000, Snohomish County approved a Microsoft Master Services Agreement (Original Contract ECAF 2000-0770), which allows for the Department of Information Technology to obtain consulting services under a mutually agreed upon Work Order for continued Microsoft Performance Support Services. Performance Support Services allow for access to high level support professionals that advise County IT staff on a variety of items from product suites, refining licenses, product capabilities, technical account representatives, and consultation for technical support. Annual payment is required under the contract.
