APPROVING AND AUTHORIZING THE COUNTY EXECUTIVE TO SIGN PUBLIC WORKS BOARD CONSTRUCTION LOAN CONTRACT NUMBER PC22-96103-067 FOR THE 36TH / 35TH AVE W IMPROVEMENT PROJECT

WHEREAS, Snohomish County (the County) has identified the need to construct the 36th / 35th Ave W Road Project (the "Project"); and

WHEREAS, the Project is included in the Transportation Element of the Snohomish County Growth Management Act Comprehensive Plan; and

WHEREAS, the Project is included in the County's 2022-2027 Transportation Improvement Program (TIP); and

WHEREAS, the estimated cost of the Project is \$11,075,000; and

WHEREAS, the County has to date secured funding for the Project in the amount of \$8,075,000; and

WHEREAS, the County applied for a \$3,000,000 Washington State Public Works Board Construction Loan for the Project; and

WHEREAS, the Washington State Public Works Board, acting under the authority of chapter 43.155 RCW, awarded the County a Public Works Board Loan, in the amount of \$3,000,000, for the Project under Construction Loan Contract Number PC22-96103-067.

NOW, THEREFORE, BE IT ORDAINED:

Section 1. The County Council hereby adopts the foregoing recitals as findings of fact and conclusions as if set forth in full herein.

Section 2. The Snohomish County Council approves and authorizes the Snohomish County Executive or designees, to execute the Public Works Board Construction Loan Contract Number PC22-96103-067, attached hereto as Exhibit A, incorporated and made a part hereof.

At the hearing, Council may consider alternatives/amendments to the proposed ordinance.
