

**AMENDMENT 1 TO THE AGREEMENT FOR PROFESSIONAL SERVICES WITH
AALTA, LLC**

This Amendment 1 to the "Agreement for Professional Services Between Snohomish County and Aalta, LLC" for Database Administration Services (the "Agreement"), executed on December 12, 2019, by and between Snohomish County, a political subdivision of the State of Washington (the "County") and Aalta, LLC, a Washington company (the "Contractor") is made and entered into on this 29th day of May, 2024.

RECITALS

WHEREAS, Snohomish County and Aalta, LLC are the parties to that certain Agreement executed on December 12, 2019; and

WHEREAS, the Agreement is effective through December 11, 2024; and

WHEREAS, the parties wish for the Agreement to automatically renew annually on the anniversary date unless terminated by the County in accordance with the Agreement; and

WHEREAS, the parties have agreed to an annual fee of \$112,000.00 beginning December 12, 2024, with an annual increase thereafter of 3.5%.

NOW, THEREFORE, for and in consideration of the mutual benefits conferred on both parties, the parties agree as follows:

1. Section 2 Term of Agreement; Time of Performance is replaced in its entirety with the following:

This Agreement shall be effective upon execution (the "Effective Date") and shall renew automatically on the annual anniversary date unless terminated by the County in accordance with Section 21 of the Agreement. Pricing shall remain firm-fixed for the initial term of the Agreement, and annual increases in years 2-5 shall not exceed 3%. Beginning December 12, 2024, the annual fee shall be \$112,000 with an annual increase thereafter of 3.5%. The Contractor shall commence work upon the Effective Date. PROVIDED, HOWEVER, that the County's obligations after December 31, 2024, are contingent upon local legislative appropriation of necessary funds for this specific purpose in accordance with the County Charter and applicable law.

2. Schedule B Compensation is replaced in its entirety with Schedule B-1 Compensation, which is incorporated herein by this reference,
3. All other terms of the Master Agreement shall remain in full force and effect, except as expressly modified by this Amendment 1.

Schedule B-1
Compensation

Aalta shall provide to Snohomish County a dedicated Data Base (DB) Team Monday- Friday, during the core working hours to provide DB support. In addition, Aalta shall provide 24 hour, seven days a week on-call availability for a monthly fixed price as listed in the table below. The DB team will conduct DB Managed Services and any associated work as outlined by the County in Schedule A, Scope of Services, and solely directed by the County. After hours on-call support exceeding 60 hours in any calendar month shall be charged at the rate of \$150 per hour.

On-Call Technical Support Hours

24 x 7 On-Call support hours are those hours that are provided on weekends, holidays and any hours outside of the County’s core working hours. On-call support hours required beyond 60 hours in a calendar month will be billed to the County at the rate of \$150 per hour.
