**Subject:** Conditioned Budget Funds – Secure Withdrawn Management and Stabilization (SWMS) facility

**Scope:** Motion 24-131 would release funds for phase 1 and 2 of the study.

**Authority Granted:** n/a

**Background:** Council adopted the 2024 budget through [Ordinance 23-121](#) on November 8, 2023. Included in that budget was \$1 million dollars for a study and potential startup costs for a Secure Withdrawal Management Stabilization facility. Along with the funding, Council included a budget condition that allowed for the release of a portion of these funds at three different junctures<sup>1</sup>:

- 1) funds to obtain someone for an initial walk through,
- 2) funds to hire the consultant for a detailed architectural analysis; and
- 3) funds for implementation/construction.

**Requested Action:** For Council to consider taking action.
