1. Ordinance 23-071, approving the acceptance of a statutory warranty deed and establishing 87th Ave SE as a new county road

2. Ordinance 23-067, relating to sponsorships and licenses at County Parks and the Fair Park, amending Chapters 2.32 SCC and adding new Sections to Chapters 2.16 and 2.32 SCC

Council Chair Mead opened the hearing and the clerk read the ordinance title into the record.

Deb Bell, Senior Legislative Analyst, provided a staff report on the proposed Code amendment to allow for licenses and sponsorship agreements for contributions to park properties and the Evergreen State Fairgrounds.

Councilmember Dunn questioned the process for approval of sponsorship agreements and requested for additional time for review and continuance of the public hearing.

Council Chair Mead opened the hearing for public testimony. There being no persons present wishing to testify, he noted that public testimony will remain open until the continuance of the public hearing, and called for a motion or discussion of the Council.

3. Ordinance 23-072, relating to storm and surface water management; amending SCC 25.20.055 to extend service charges for Lake Ketchum restoration

Council Chair Mead opened the hearing and the clerk read the ordinance title into the record.

Deb Bell, Senior Legislative Analyst, provided an overview of the proposed Code amendment to extend the service charges for Lake Ketchum restoration from January 1, 2024 through December 31, 2028.
