6 ADOPTING CHANGES IN VOTING PRECINCTS PURSUANT TO
7 RCW 29A.16.040, RCW 29A.16.050 AND CHAPTER 2.47 SCC; AMENDING
8 CHAPTER 2.47 SNOHOMISH COUNTY CODE
9

10 WHEREAS, SCC 2.47.040(2) provides that the County Auditor may temporarily
11 adjust precinct boundaries to maintain conformance with applicable state laws, and that
12 such revisions to voting precincts must be submitted to the County Council for adoption
13 by ordinance no later than May 1 of each year; and
14

15 WHEREAS, Exhibit A, attached hereto, sets forth the precinct changes made by
16 the Auditor since April 13, 2022, including those temporarily adjusted to maintain
17 conformance with applicable state law, resulting in a total of 852 voting precincts in
18 Snohomish County. Exhibit A details 11 changes to precincts due to growth in the
19 number of voters in a precinct and 6 changes to precincts due to city annexations;

21 NOW, THEREFORE, BE IT ORDAINED:
22

23 Section 1. The Council finds that pursuant to the authority of SCC 2.47.040(2), the Auditor
24 made those adjustments to precinct boundaries since April 13, 2022, that are set forth in
25 Exhibit A, attached hereto and incorporated herein by this reference.

27 Section 2. Snohomish County Code Section 2.47.030, last amended by Ordinance 22-013
28 on April 13, 2022, is amended to read:

30 **2.47.030 Precincts adopted.**
31

32 (1) The adopted voting precinct boundaries for the county are those set forth in
33 the precinct map books maintained on file with the clerk of the council and the
34 Snohomish county auditor's office, subject to revision from time to time in accordance
35 with SCC 2.47.040.

37 (2) To implement boundary changes resulting from redistricting following the
38 federal decennial census and to implement changes that are necessary to maintain
39 conformance with applicable laws in accordance with SCC 2.47.040, the precinct
40 boundaries adopted by subsection (1) are revised cumulatively as set forth in the
41 following documents:

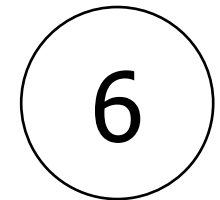
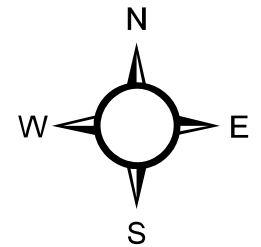
Lynnwood 33 and Lynnwood 29 to Lynnwood 35 (new) to reduce voter count

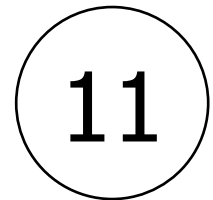
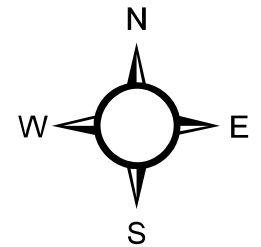
Cedarhome to Stanwood 6 due to annexation - Ord 1504

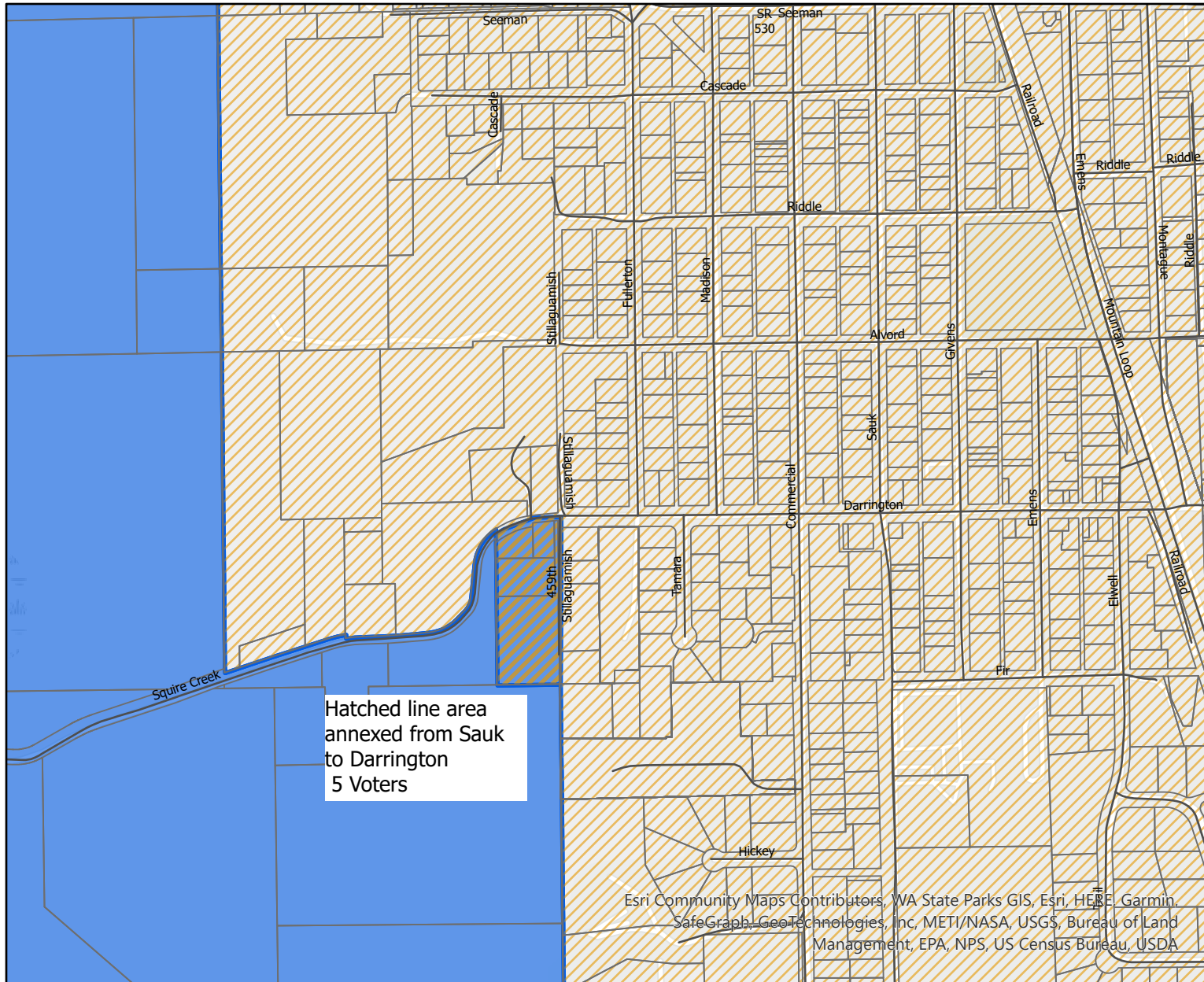

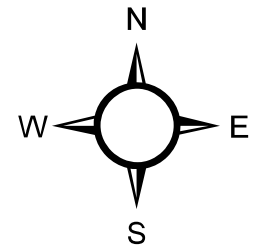
Sauk into Darrington due to annexation - Ord 770

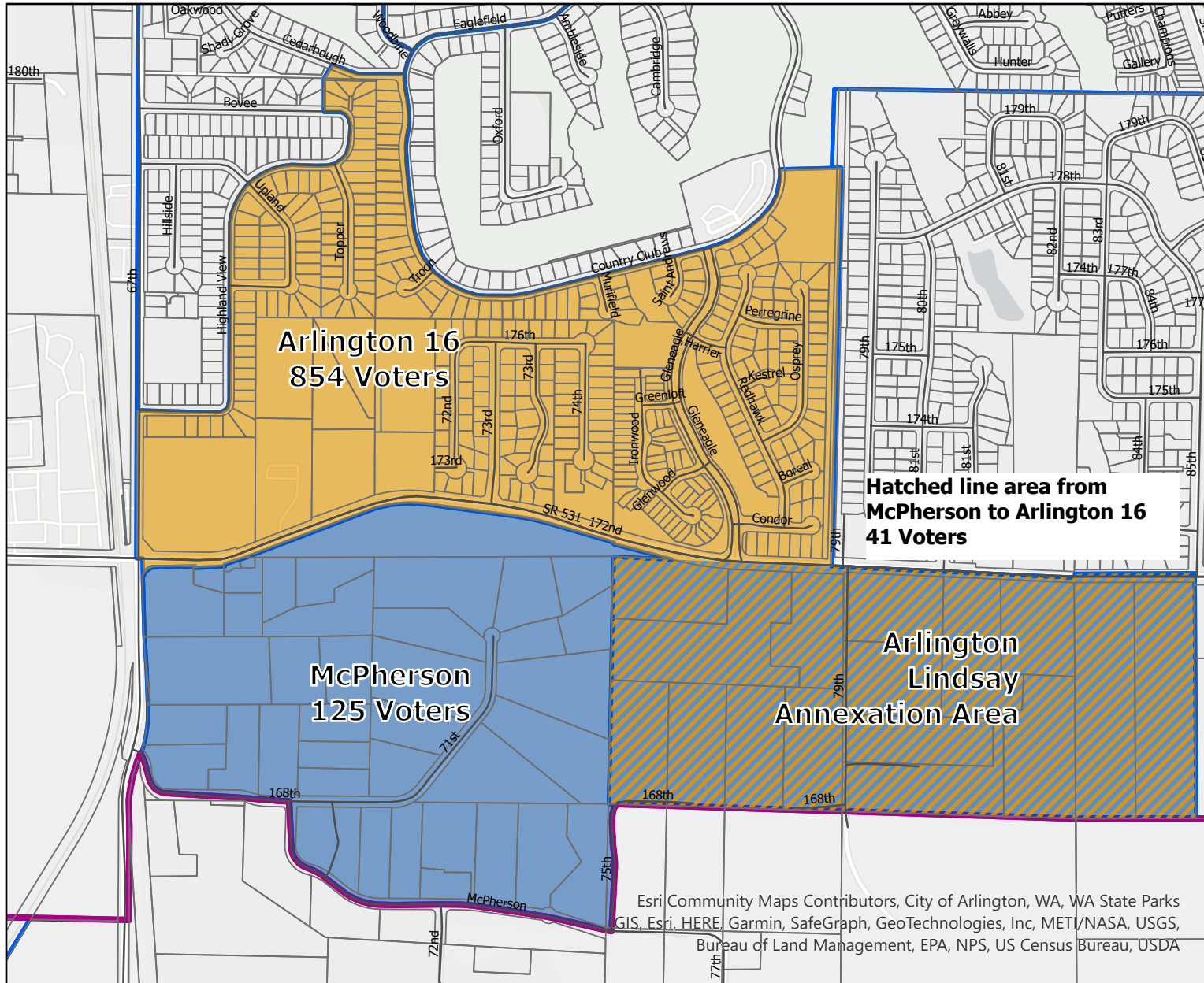

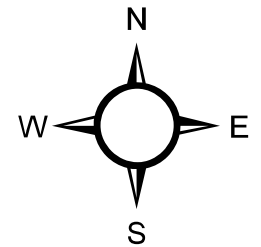
McPherson to Arlington 16 due to annexation - Ord 2022-003

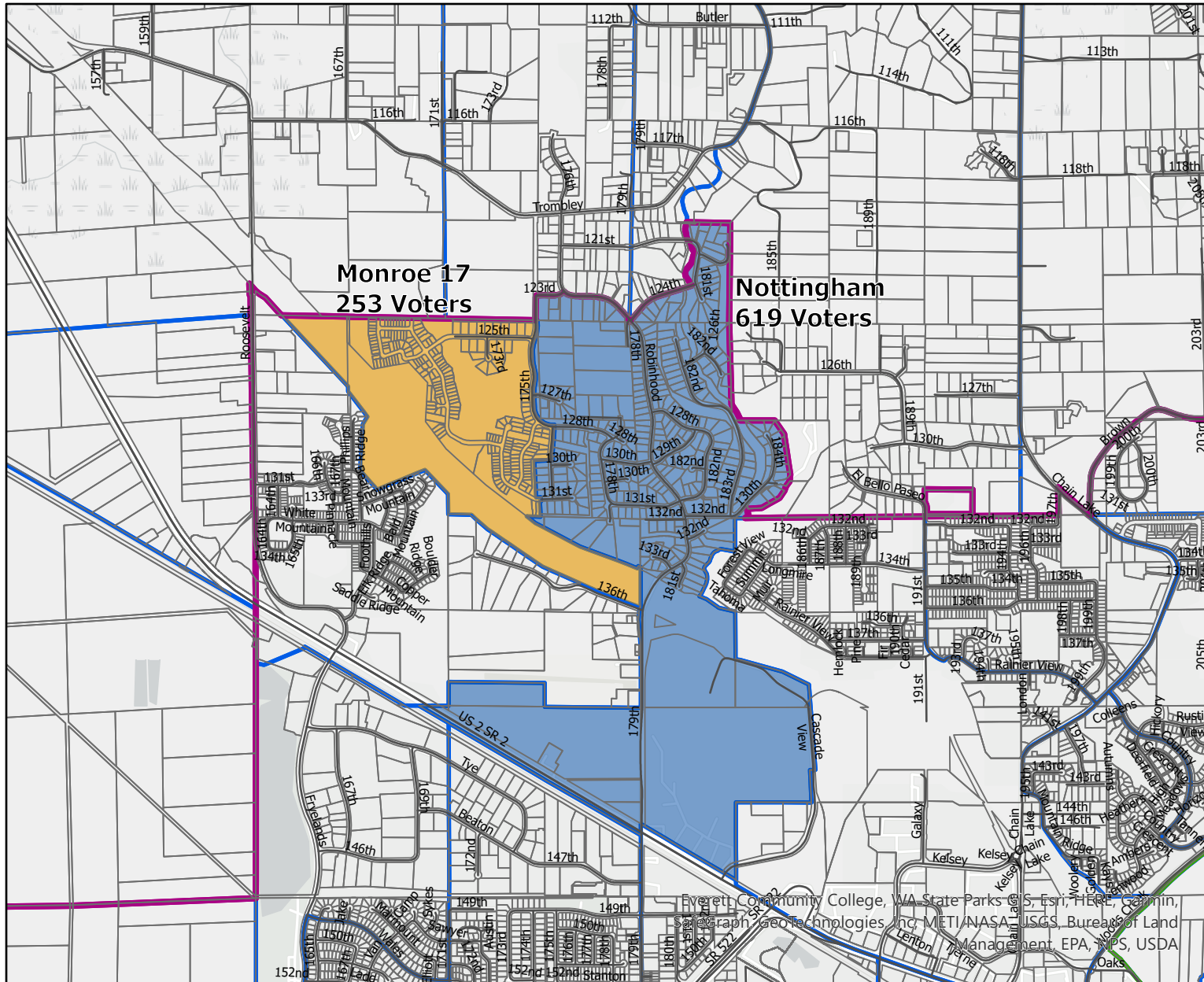

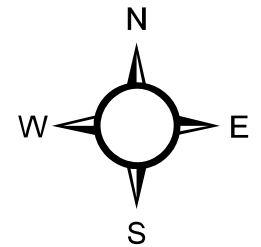
Nottingham to Monroe 17 (new) due to annexation - Ord 002/2022
