PROPOSED ORDINANCE NO. 23-141

RELATED TO THE 2023 BUDGET; MAKING AN EMERGENCY APPROPRIATION IN GENERAL FUND 002 TO PROVIDE EXPENDITURE AUTHORITY FOR UNANTICIPATED GOVERNMENTAL FUND LEASE COSTS

<u>Summary:</u> The ordinance provides emergency budget appropriation in General Fund 002 in the amount of \$642,951.22. Governmental Accounting Standards Board (GASB) Statement Number 87 requires revenue and expenditure entries to properly account for the leases in our financial recordkeeping. The three affected 2023 leases are: Human Services Department in General Fund 002 for \$377,246.87, the Sheriff's Office in General Fund 002 for \$144,945.03, and the Auditor's Office in General Fund 002 for \$120,759.32.

At the Public Hearing, the Council may consider amendments to the proposed ordinance.
