In April 2018 Snohomish County authorized the surplus and disposition of 31-acres of the Cathcart South Property, via Motion 18-054. As a condition of the Purchase and Sale Agreement, the buyer (Pacific Ridge) is required to construct an approximately 150 stall park & ride facility, unofficially known as Cathcart Park & Ride, on portions of the Road Fund property. The Purchase and Sale Agreement was executed on April 15, 2020, and as per the condition, Snohomish County and Snohomish County Public Transportation Benefit Area, and the buyer (Pacific Ridge) executed the PSA on July 15, 2022. The new Park & Ride is anticipated to be opening in August 2025, and Community Transit and Snohomish County wish to enter into an agreement providing for the operation and maintenance of the new facility.

Requested Action: For Council to move the motion to GLS on May 14, 2025, for consideration.
