6. Committee of the Whole

a. Ordinance 22-037, relating to environmental review;
Increasing exemption thresholds for minor new construction and adopting new categorical exemptions per the State Environmental Policy Act to Promote Infill Development in Urban Growth Areas; Amending existing and adding new sections in chapters 30.43F, 30.61, 30.70 and 30.91I of Snohomish County Code

Ryan Countryman, Sr. Legislative Analyst, provided a detailed staff report and explained this ordinance would implement changes authorized by the State Legislature last year.

Mr. Countryman summarized his staff report and said this ordinance would increase exemption thresholds for minor new construction and adopt infill categorical exemptions by making a number of changes throughout code. He said the Planning Department has indicated support for this ordinance.

Mr. Countryman responded, in detail, to various questions from councilmembers.

ACTION: Vice-Chair Mead made a motion to set time and date for a public hearing for September 28th at 10:30 a.m. Councilmember Nehring seconded the motion and it carried unanimously by the four members present.

b. Motion 22-369, authorizing the County Executive to sign Interagency Agreement Contract Number: 23-63333-124 with the Washington State Department of Commerce

Ryan Countryman, Sr. Legislative Analyst, provided a staff report. He explained that this motion authorizes an interagency agreement related to a grant awarded by the Department of Commerce to incorporate planning for climate change into the County's Comprehensive Plan.

Mr. Countryman said the interagency agreement would be effective upon execution through June 30, 2023. There is no budget change necessary to perform the work and Planning and Development Services has recommended approval.

ACTION: Vice-Chair Mead made a motion to approve Motion 22-369. Councilmember Nehring seconded the motion and it carried unanimously by the four members present.

Motions 22-359 and 22-360 were discussed together.

c. Motion 22-359, to approve the agreement with the City of Arlington to provide funding for Haller Park amenities, an approved Small Capital Projects Partnership (SCPP) Project

ACTION: Vice-Chair Mead made a motion to approve Motion 22-359. Councilmember Low seconded the motion and it carried unanimously by the four members present.

d. Motion 22-360, to approve the agreement with the City of Everett to provide funding for off-leash dog area at Senator Henry M Jackson Park, an approved Small Capital Projects Partnership (SCPP) project

Jim Martin, Sr. Legislative Analyst, explained that each motion would approve a contract with the cites of Arlington and Everett in the amount of \$10,000.00 each for previously awarded Small Capital Projects Partnership grants. Once approved each agency will be able to submit invoices for reimbursement for their respective projects.

ACTION: Vice-Chair Mead made a motion to approve Motion 22-360. Councilmember Nehring seconded the motion and it carried unanimously by the four members present.
