APPROVING AMENDMENT 1 TO THE MASTER SERVICES AGREEMENT FOR
VEHICLE IDENTIFICATION CAMERAS WITH FLOCK GROUP, INC.

WHEREAS, Flock Group, Inc. has developed vehicle identification cameras that are able to recognize license plates and unique vehicle characteristics. The system does not rely on facial recognition or detect the gender or race of the vehicle occupants; and

WHEREAS, Snohomish County entered into an agreement on January 23, 2025, with Flock Group, Inc. for the installation of, and access to 12 Flock Cameras and the Flock OS System for a two-year term with three successive one-year renewal options; and

WHEREAS, Flock Group, Inc. has determined that existing poles and structures can be utilized for camera installation, thereby lowering the cost to Snohomish County; and


WHEREAS, the parties desire to update pricing in the agreement to reflect this cost savings; and

WHEREAS, Snohomish County desires to decrease the current contract amount by \$5,500;

NOW, THEREFORE, ON MOTION, the County Council hereby approves the Amendment Replacing Attachment A in the Master Services Agreement for Vehicle Identification Cameras with Flock Group, Inc. and authorizes the County Executive to sign the necessary contract documents.

AMENDMENT NO. 1 TO THE MASTER SERVICE AGREEMENT
BETWEEN SNOHOMISH COUNTY AND FLOCK GROUP, INC.

This Amendment No. 1 to the Master Service Agreement Between Snohomish County, a political subdivision of the State of Washington, and Flock Group, Inc, a Delaware Corporation with a place of business at 1170 Howell Mill Road NW Suite 210, Atlanta, GA 30318
