AUTHORIZING THE SNOHOMISH COUNTY EXECUTIVE TO SIGN AMENDMENT NO. 6  
WITH PRODIGIQ, INC. FOR SOFTWARE AND SUPPORT SERVICES AT THE  
SNOHOMISH COUNTY AIRPORT AT PAINE FIELD

WHEREAS, the Airport requires a contract amendment to extend the contract duration and annual software and support services; and

WHEREAS, the Airport requires a new database system to manage leases, licenses, maintenance work orders, aircraft accident information, FAA Part 139 inspections, Foreign Object Debris collection, storm water maintenance records, Operations Log, and SMS; and

WHEREAS, ProDIGIQ is a database company that is focused exclusively on airports and airport related database programs; and

WHEREAS, the County selected ProDIGIQ pursuant to RFP 12-15SR as the best company to provide database services and support to replace six aging databases at the Airport; and

WHEREAS, the database system will provide a comprehensive solution for the Airport and the ability to monitor and accurately log crucial real-time airport information; and

WHEREAS, the system will automate daily Airport tasks and maintain FAA compliance with Part 139 at a reasonable cost; and

WHEREAS, the contract extension and annual software and support services will not exceed \$64,992;

NOW, THEREFORE, ON MOTION, the County Council authorizes the County Executive to sign Amendment 6 to the Software and Support Services Agreement with ProDIGIQ, Inc. in the form attached hereto.

**AMENDMENT NO. 6 TO THE SOFTWARE SERVICE & SUPPORT AGREEMENT  
BETWEEN SNOHOMISH COUNTY AND PRODIGIQ**

THIS AMENDMENT NO. 6 to that certain SOFTWARE SERVICE & SUPPORT AGREEMENT, dated August 26, 2015, (the “Agreement”) is entered into as of this 8th day of July, 2024 by and between Snohomish County, a home rule charter county and a political subdivision of the State of Washington (the “County”), and ProDIGIQ, licensed to do business in the State of California (the “Contractor”).

**RECITALS**

WHEREAS, the County and ProDIGIQ entered into that certain Agreement executed on September, 1 2015, entitled Service and Software Agreement (the “Agreement”); and

WHEREAS, the Agreement was amended on June 11, 2018 under Amendment No. 1, which added additional Ops Log module to maintain workflow; Amendment No. 2 on September 2, 2020, which extended the term of the agreement through September 30, 2022, and pricing increase for on-going annual costs; Amendment No. 3 on November 10, 2020, which added upgrades to current Incident/Accident module; Amendment No. 4 on February 10, 2022 which added upgrades to Maintenance Management module and extended the term of the agreement through September 30, 2024; Amendment No. 5 on August 31, 2022 which added additional Risk Management module, integration of Cartegraph and additional hangar inspections to the Lease Management system; and

WHEREAS, the original RFP 12-15SR allows for the expansion of the Service and Software Agreement; and

WHEREAS, the Airport and ProDIGIQ have negotiated and amended the Agreement as set forth herein;

NOW, THEREFORE, in consideration of the covenants hereinafter set forth and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the County and Contractor agree that the Agreement shall be amended as follows:

1. Amend Section 1.01, Scope of Services: As allowed by paragraph 3.03 of the Software Service & Support Agreement the service will extend existing annual support for the following: Operations, Maintenance, and Lease Management System at an annual recurring cost of \$28,512; Operations Log Module at an annual recurring cost of \$6,480; and ProsafeT Safety Risk Management System at an annual recurring cost of \$30,000. The total cost for this amendment is \$64,992 shown in **Exhibit D**.
2. Term of Agreement; Time of Performance: This Amendment extends the term of the agreement until September 30, 2025.

3. All other terms and conditions of the Agreement, not inconsistent with this Amendment, shall remain in full force and effect.
