Motion 23-555 would approve a new contract with Purpose. Dignity. Action. (PDA). PDA performs the administrative functions of the County's LEAD program. The new contract holds the same provisions as the prior contract, continuing services through June 30, 2024.

**Background:** In June 2020, the Council passed Motion 20-212<sup>1</sup> approving a \$1.69 million grant award from the Washington State Health Care Authority (HCA) to implement a Law Enforcement Assisted Diversion (LEAD) program<sup>2</sup> from June 9, 2020 through June 30, 2021. The county entered into an agreement with the PDA on August 16, 2021 to reimburse for LEAD Project Management Expenses; the original agreement was approved by Motion 21-266.<sup>3</sup> There have been three amendments to the contract and a fourth is necessary (and will be retroactive as the contract term ended September 30, 2023). In addition, a new contract to replace the expired one has been submitted for consideration.

**Requested Action:** Move to GLS December 13<sup>th</sup> for consideration.
