# **CALL TO ORDER**

Committee Chair Dunn called the meeting to order at 10:12 a.m. and provided instructions for those wishing to provide public comment for both in-person and remote via Zoom.

## **ACTION ITEMS**

**1.** Motion 23-076, authorizing the Executive to sign a contract for economic development services with Greater Seattle Partners

Jim Martin, Sr. Legislative Analyst, provided a staff report and explained this motion would authorize the Executive to sign the 2023 contract with Greater Seattle Partners. Mr. Martin noted the agreement is through December 31, 2023, and has a not to exceed amount of \$100,000.00.

Chair Dunn asked if this is the same agreement as last year. Mr. Martin indicated it was the same, with a possible slight amount difference due to ARPA (American Rescue Plan Act) funding last year.

2. Motion 23-077, authorizing the Executive to sign a contract for economic development services with Economic Alliance Snohomish County

Jim Martin, Sr. Legislative Analyst, provided a staff report and explained this motion would authorize the Executive to sign the 2023 contract with Economic Alliance Snohomish County with the term of December 31, 2023, and a not to exceed amount of \$100,000.00. Mr. Martin noted that this is a reduction of \$50,000.00 from last year's contract, which was increased with one time ARPA (American Rescue Plan Act) funding. Discussion ensued about last year's ARPA funding.

**3.** Motion 23-061, appointing Ms. Maggie Kase to the Snohomish County Historic Preservation Commission

Jim Martin, Sr. Legislative Analyst, provided a staff report which discussed the background of Maggie Kase and said if appointed, her term will expire on January 31, 2026. Mr. Martin noted there is a scrivener's error in the Motion indicating that this is a re-appointment, when in fact, it is an initial appointment.

**4.** Motion 23-062, appointing Ms. Taylor Russell to the Snohomish County Historic Preservation Commission

Jim Martin, Sr. Legislative Analyst, provided a staff report which discussed the background of Taylor Russell. If appointed, she would represent District 5 and her term will expire on December 31, 2026.

Motion 23-089, authorizing the County Executive to sign a contract for professional services for tax payment processing with Retail Lockbox Inc.

Jim Martin, Sr. Legislative Analyst, provided an overview of the proposed agreement and explained the motion approves authorization for the Executive to sign the contract with Retail Lockbox Inc. Mr. Martin indicated the term of the contract is through February 15, 2024, with a potential for up to two additional two-year terms at the sole discretion of the County, not to exceed \$45,000.00 for the initial term.

6. Motion 23-088, authorizing the Snohomish County Executive to sign contract amendments with Joyce Ziker Partners, PLLC to reflect merger with Hillis Clark Martin & Peterson, P.S. for legal services for the Snohomish County Airport

Jim Martin, Sr. Legislative Analyst, provided a staff report and explained the motion would approve contract amendments, revising the names on three contracts. Mr. Martin further indicated Amendment 1 to Other Areas provides additional compensation of \$50,000.00, and Amendment 2 increases the not to exceed amount to \$125,000.00 for legal services.

7. Motion 23-079, approving award of council project funds (Second Chance Foundation)
