Snohomish School District No. 201, a local school district organized under the laws of the State of Washington, has applied to Snohomish County, Washington, for a non-exclusive franchise to construct, maintain, operate, replace and repair telecommunication systems in, on, across, over, along, under, and/or through public rights-of-way within the following portions of unincorporated Snohomish County:


