AUTHORIZING THE SNOHOMISH COUNTY EXECUTIVE TO SIGN AMENDMENT NO. 1 WITH GORDON, THOMAS HONEYWELL GOVERNMENTAL AFFAIRS (GTH) TO PROVIDE PROFESSIONAL FEDERAL GOVERNMENTAL AFFAIRS RELATIONS, LOBBYING, AND RELATED SERVICES FOR SNOHOMISH COUNTY

WHEREAS, Snohomish County requires a contract amendment with Gordon Thomas Honeywell Governmental Affairs LLC (GTH) to extend the contract duration of professional services provided for federal governmental affairs; and

WHEREAS, Gordon Thomas Honeywell Governmental Affairs, LLC (GTH) was chosen to be awarded the contract for the County's federal governmental relations through the Request for Proposal process, RFP 22-027SB; and

WHEREAS, the initial contract provides for two additional one-year extensions; and


WHEREAS, GTH provides a comprehensive range of services under the agreement including development of legislative guidelines, annual legislative agenda, policy documents, and participation in regional organizations that influence the County's legislative objectives; and

WHEREAS, the contract extension increases compensation by \$114,000, with a total contract value not to exceed \$342,000;


NOW, THEREFORE, ON MOTION, the County Council authorizes the County Executive to sign Amendment No. 1 with Gordon Thomas Honeywell Governmental Affairs LLC as attached hereto.

All other terms and conditions of the RFP shall remain unchanged.


