AUTHORIZING THE SNOHOMISH COUNTY EXECUTIVE TO SIGN AMENDMENT NUMBER 06 WITH THE AMERICAN ASSOCIATION OF AIRPORT EXECUTIVES (AAAE) FOR DESIGNATED AVIATION CHANNELING (DAC) AND COMPUTER BASED TRAINING (CBT) SERVICES AT SNOHOMISH COUNTY AIRPORT

WHEREAS, the Airport requires a contract amendment to include Safety Management System (SMS) training and nondiscrimination Title VI training for compliance with recent Federal Aviation Administration (FAA) guidelines; and

WHEREAS, AAAE is a company that is focused exclusively on airports, providing airport related training; and

WHEREAS, the County selected AAAE pursuant to RFP 15-18SR as the best company for online training and DAC services to support TSA compliance at the Airport; and

WHEREAS, the online training services will help the Airport meet FAA Part 139 compliance; and

WHEREAS, the system will automate daily tasks and maintain record compliance at a reasonable cost; and

WHEREAS, the contract amendment increases compensation by \$3,500, with a total contract value not to exceed \$238,450;

NOW, THEREFORE, ON MOTION, the County Council authorizes the County Executive to sign Amendment No. 6 with the American Association of Airport Executives in the form attached hereto.

#### AMENDMENT NO. 5 TO AGREEMENT FOR PROFESSIONAL SERVICES

THIS AMENDMENT (the "Amendment") is made by and between SNOHOMISH COUNTY, a political subdivision of the State of Washington (the "County"), for services at the Snohomish County Airport at Paine Field, and the American Association of Airport Executives (AAAE), a wholly owned and operated not-for-profit entity (the "Contractor"). In consideration of the mutual benefits and covenants contained herein, the parties agree as follows:

- 1. <u>Purpose of Agreement; Additional Scope of Services</u>. The purpose of this Amendment is to add an additional scope of work to include two new training modules for non-custom Title VI and SMS trainings. Compensation for the additional work shall not to exceed \$3,500, as shown on Schedule Exhibit B.
- 2. <u>Compensation.</u> This Amendment amends original contract Section 3, Compensation, with the attached Schedule Exhibit B.
- 3. All other terms and conditions of the Agreement, not inconsistent with this Amendment, shall remain in full force and effect.
