**CALL TO ORDER**

## DISCUSSION ITEM

1. Courthouse Security Update [2023-0027](#)  
Presiding Judge Appel

Discussion ensued regarding the events of December 12, 2022, at the Snohomish County Courthouse and subsequent changes to campus security. Presiding Judge Appel also spoke to a pending Courthouse Security Site Assessment and emergency alert system. He said security measures will also be evaluated at Denny Juvenile Detention Center and what the expenses surrounding updates to both facilities may look like.

Presiding Judge Appel responded to various questions throughout the discussion.

## ACTION ITEMS

1. Motion 22-552, approving and authorizing the Snohomish County Executive to sign an Interlocal Agreement between Snohomish County and Monroe School District for Trauma-Informed Practices Consultation [2022-1308](#)

Heidi Beazizo, Chief of Staff, provided a staff report. She explained that this motion would approve an Interlocal Agreement with the Monroe School District for Trauma-Informed Consulting Services. She said the term of the agreement is September 1, 2021 through August 31, 2024, for a total of \$124,000.00.

2. Motion 22-557, approve and authorize the Snohomish County Council to execute the Interlocal Agreement with the city of Monroe regarding law enforcement embedded social worker [2022-1325](#)

Heidi Beazizo, Chief of Staff, provided a staff report. She explained that this motion approves an Interlocal Agreement with the city of Monroe for their Law Enforcement Embedded Social Worker Program. She said that the cost of the FTE in 2023 is higher than the amount included in the Grant Work Plan, by more than \$50,000.00, constituting Council action. She said the term is January 1, 2023 through December 31, 2023, for a total cost of \$146,823.00.

3. Motion 22-563, approving a budget transfer in General Fund 002, [2022-1350](#)  
District Court

Heidi Beazizo, Chief of Staff, provided a staff report. She explained that this motion would approve a budget transfer in District Court Programs. She explained that this motion would transfer \$150,000.00 from Program 330 to Program 240. She said there is a net zero impact on the 2023 Budget, but this motion would impact the 2022 Budget.
