WHEREAS, Motion 21-089 and Motion 22-282 provided Snohomish County Council direction for the distribution of funds collected under RCW 43.79.520 and specifies the public school districts and institutions of higher education that are within the boundaries of Sound Transit and have a core mission of improving educational outcomes and required the annual submission of an expenditure plan and report, detailing use of the funds, from each fund recipient to Council; and

WHEREAS, annual service and expenditure plans are approved annually by Council as amendments to PSTAA interlocal agreements, and these are approved by motion pursuant to Ordinance 22-072; and

WHEREAS, council approved Amendment #2 to the PSTAA Interlocal Agreement with Snohomish School District via Motion 24-307; and

WHEREAS, council approved Amendment #7 to the PSTAA Interlocal Agreement with Washington State University - Everett via Motion 24-309; and

WHEREAS, council approved Amendment #5 to the PSTAA Interlocal Agreement with Mukilteo School District via Motion 24-305; and

WHEREAS, council approved Amendment #5 to the PSTAA Interlocal Agreement with Everett Public Schools via Motion 24-304; and

WHEREAS, council approved Amendment #6 to the PSTAA Interlocal Agreement with Everett Community College via Motion 24-303; and

WHEREAS, council approved Amendment #6 to the PSTAA Interlocal Agreement with Edmonds School District via Motion 24-302; and

WHEREAS, council approved Amendment #6 to the PSTAA Interlocal Agreement with Wash State Community College Dist #23 DBA Edmonds College via Motion 24-308; and

WHEREAS, council approved Amendment #6 to the PSTAA Interlocal Agreement with Northshore School District via Motion 24-306; and

WHEREAS, each agency has submitted annual reports detailing the use and effectiveness of PSTAA funds for the ILA period September 1, 2024, through August 31, 2025;
