**Background:** OD2A: LOCAL was structured to provide jurisdictions flexible resources to improve and create local prevention activities that are informed by local data and

direct experience and improve the surveillance of drug overdoses. Grant purposes include:

- Using data to inform and tailor prevention strategies, with emphasis on reaching groups disproportionately affected by the overdose epidemic, at highest risk of overdose, and those historically underserved by prevention programs.
- Ensuring the implementation of culturally relevant interventions and the equitable delivery of prevention services, informed by data and ongoing engagement with the populations programs are intended to serve.
- Developing and growing multisectoral partnerships to strengthen the local overdose response.
