13 RECEIVED FROM THE WASHINGTON STATE OFFICE OF PUBLIC DEFENSE

15 WHEREAS, Motion 26-235 approved Interagency Agreement No. FY270136
16 between the Washington State Office of Public Defense and Snohomish County (Office
17 of Public Defense) for an award in the amount of \$938,248.38; and
18

19 WHEREAS, the amount awarded to the County in Interagency Agreement No.
20 FY270136 for public defense improvements exceeds the 2025-2026 adopted County
21 Office of Public Defense budget for this award, and a supplemental appropriation for
22 additional expenditure authority therefore is needed.

24 NOW, THEREFORE, BE IT ORDAINED:

26 Section 1. The County Council makes the following findings of fact: A
27 supplemental appropriation is necessary in the Office of Public Defense in General
28 Fund 002, in the 2025-2026 budget, in the amount of \$938,248.38, to provide
29 expenditure authority for funds received from WA State OPD.
