MOTION NO. 22-235

APPROVING THE APPORTIONMENT OF
2022 PUBLIC UTILITY DISTRICT PRIVILEGE TAXES

WHEREAS, Snohomish County has received the amount of \$7,280,666.24 from the State of Washington for Snohomish County Public Utility District No.1, privilege taxes; and

WHEREAS, RCW 54.28.090 authorizes the County Council to stipulate the distribution of said funds subject to certain limitations; and

WHEREAS, the County Council has determined that these funds should be distributed as set forth below;

NOW, THEREFORE ON MOTION, Snohomish County Council hereby authorizes and directs the Snohomish County Treasurer to distribute \$2,829,919.08, representing 3/4 of 1% of revenue derived from the cities and towns, to the cities and towns in accordance with the schedule below, and to deposit the balance, \$4,450,747.16, into the General Fund.
