Consideration:

The proposed motion would approve and authorize the notice to proceed with payment for the year 2023-2024 Microsoft Support Services, under SCC 3.04.140(8) and 3.04.190.

Background:

On May 18, 2000, Snohomish County approved a Microsoft Master Services Agreement, which allows for the Department of Information Technology to obtain consulting services under a mutually agreed upon Work Order for continued Microsoft Performance Support Services. The County makes a payment annually under the contract.

Performance Support Services allow for critical access to high level support professionals that advise County IT staff on a variety of items from product suites, how to refine licenses, assist in managing the County's Microsoft product capabilities, technical account representatives, as well as on-site or remote consultation for direct technical support 24/7, including 30-minute response times for critical issues and on demand training resources.

Current Proposal:

Scope: Approval by motion is sought from Council to approve and authorize the notice to proceed with payment for the Microsoft Performance Support Renewal 2023-2024.

Duration: The term of this agreement is from June 1, 2023, through May 31, 2024.

Fiscal Implications: The total amount payable under this agreement is \$228,355.00.

<u>2022 Budget:</u> Yes, the 2023 Budget includes appropriation authority.

<u>Future Budget Impacts</u>: Funding for this service was anticipated and included in the approved 2023 Department of Information Technology budget.
