## **Consideration:**

The proposed motion would authorize and approve the County Executive to execute Amendment 1 to the Master Services and Purchasing Agreement between Snohomish County and Axon Enterprise, Inc., in accordance with SCC 3.04.140(8).

## Background:

Snohomish County and Axon Enterprise, Inc. are party to a Master Service Agreement, first executed in April 2021 (Motion 21-150), for turnkey interview solutions that includes hardware, installation, and ongoing software to manage interview recordings.

In February 2022 the County sought additional services of equipment and implementation of a Body Camera solution for the County through RFP-22-012BC, and for new tasers to continue the original 2005 program through RFP-22-005BC. The County's evaluation team selected Axon Enterprise, Inc., following established Federal, State and County policies. Axon Enterprise, Inc was the highest scoring proposal for each RFP that met the needs of the Sheriff's Department.

## Current Proposal:

*Scope:* The proposed Amendment No. 1 would allow for the acquisition and implementation of a worn body camara system (340 units) and would allow for the replacement of the Sheriff's Office existing tasers; which also includes all components and all associated file storage, hardware, software, training, licenses, and support services.

*Duration:* The amendment allows for addition services and equipment to be added to the Master Contract; the initial term is for five years from execution with an optional 4 years.

*Fiscal Implications:* Amendment 1 costs are estimates for the first five-year term for the Body Cameras System and Tasers; the agreed to maximum contract mount of \$3,824,280.00 is for the initial term and all optional terms plus applicable sales tax.
