Subject: Amended and Restated Master Service Agreement with OpenGov, Inc.

Scope:

Snohomish County and OpenGov, Inc. wish to amend and restate the Agreement as set forth in the Amended and Restated Master Services Agreement (the "Master Agreement"). This is to reflect the software upgrade from on-premises Cartegraph Operations Management System licensing and services to Cartegraph Asset Management cloud software as a service. OpenGov has offered fixed annual renewal pricing. The Amended and Restated Master Services Agreement will allow the County to continue to use the Cartegraph platform, implement, and upgrade.

Duration: September 1, 2026, through August 31, 2030.

<u>Authority Granted:</u> Snohomish County Council approves and authorizes the County Executive to execute the Amended and Restated Master Services Agreement and associated amendments between Snohomish County and OpenGov, Inc., under SCC 3.04.140(11).

<u>Background:</u> In 2015 Snohomish County executed an agreement with Cartegraph Inc, for automated asset maintenance management system which was initially released to Road Maintenance and Solid Waste. To date five amendments have been processed to include two term extensions, additional related scope and budget, and the addition of the departments of DCNR and the Airport.
