PROPOSED ORDINANCE NO. 24-093

ESTABLISHING THE 2025 MONTHLY VEHICLE ALLOWANCE OF ELECTED OFFICIALS PURSUANT TO SCC 3.36.035(2)

<u>Summary:</u> Snohomish County Code 3.36.035 requires the Director of the Department of Facilities and Fleet to annually review average monthly Equipment Rental and Revolving (ER&R) cost for replacement, maintenance, insurance and fuel expenses of a standard size county pool vehicle and report that average monthly cost to the Council. The Director of Facilities and Fleet has determined that the average monthly ER&R cost for 2025 is \$595.56. The Council may set the elected official reimbursement for 2025 at not more than 99 percent of the average monthly ER&R cost, or \$589.60.

At the Public Hearing, the Council may consider amendments to the proposed ordinance.
