PROPOSED ORDINANCE NO. 25-069

ESTABLISHING THE 2026 MONTHLY VEHICLE ALLOWANCE OF ELECTED OFFICIALS PURSUANT TO SCC 3.36.035(2)

<u>Summary:</u> Snohomish County Code (SCC) 3.36.035 requires the Director of the Department of Facilities and Fleet to annually review average monthly ER&R cost for replacement, maintenance, insurance and fuel expenses of a standard size county pool vehicle and report that average monthly cost to the Council. The Director reviewed the average monthly ER&R cost and determined the cost to be \$705.15 for 2026. Pursuant to SCC 3.36.035(2), the County Council may set the elected official reimbursement for 2026 at not more than 99 percent of the average monthly ER&R cost at \$698.10.

At the Public Hearing, the Council may consider amendments to the proposed ordinance.
