<u>Authority Granted:</u> Approve and authorize the County Executive to sign Amendment No. 11 to the Contract for Professional Elevator Maintenance Services in the amount of \$1,200,000 for an amended total not to exceed \$1,858,696.29, and hereby authorizes the Executive to approve future amendments provided that there is sufficient budget appropriation, under SCC 3.04.140(8).

Background: Snohomish County requires Elevator Maintenance Services to keep the elevators at the Snohomish County facilities in good working order. The Facilities Management Department issued RFP 02-13 for contractors to provide elevator maintenance services. County staff determined that KONE Inc. offered the best responsive proposal. In 2014, Facilities entered into a 3-year and 8-month contract. Since then, 10 amendments have been executed that have increased the annual expenditure and extended the life of the contract.
