#### PROPOSED ORDINANCE NO. 25-036

## RELATING TO PENDING LEGISLATION; AMENDING CHAPTER 2.48 SCC

<u>Summary:</u> The ordinance amends Snohomish County Code Chapter 2.48 to require a Clerk's report on pending legislation. Current code requires a report for Ordinances that are pending introduction but does not have a comparable requirement related to motions. This code change would require the Clerk's report on pending legislation include motions that are 35 days past assignment to committee. The report would be included in the Tuesday Administrative Session agenda under "Clerk's report on pending legislation."

At the Public Hearing, the Council may consider amendments to the proposed ordinance.
