Deb Bell, Sr. Legislative Analyst, provided a staff report. She explained that Facilities and Fleet Department has identified the need to upgrade the existing security system at the county jail facilities and to improve operations at the corrections bureau. The proposed agreement was negotiated with a not to exceed fixed amount of \$175,000.00 with a term of one year, with an option to extend for an additional year.

**ACTION:** Councilmember Nehring made a motion to approve Motion No. 22-267. Councilmember Wright seconded the motion and it carried unanimously by the four members present.

b. Motion 22-240, 2022 budget transfer from Nondepartmental to Sherriff's Office Corrections Bureau related to achievement of revenue target and satisfaction of criterion to receive contingent authority

Jim Martin, Sr. Legislative Analyst, provided a staff report. He said the proposed motion would transfer \$500,000.00 from Nondepartmental Contingent Obligations to Salaries within programs of the Corrections Bureau.

**ACTION:** Councilmember Nehring made a motion to approve Motion No. 22-240. Councilmember Wright seconded the motion and it carried unanimously by the four members present.

**c.** Motion 22-260, appointing Sarah Cho to the Snohomish County Tourism Promotion Area (TPA) Advisory Board

Jim Martin, Sr. Legislative Analyst, provided background information for Sarah Cho and said this motion would appoint Ms. Cho as the District 1 Non-Lodging representative, for a term expiring December 31, 2024.

**ACTION:** Councilmember Nehring made a motion to approve Motion No. 22-260. Councilmember Wright seconded the motion and it carried unanimously by the four members present.
