





I am writing you today to give my strong recommendation for Jennifer DeJong for the position of Cascade District Court Judge. I met Jennifer while I was working for the Snohomish County Prosecutors Office in the juvenile division. I was the victim/witness advocate assigned to the sexual assault/abuse cases, hate crime cases, and violent felony cases. Prior to that I was assigned to Evergreen District Court and Everett District Court.

I offer my recommendation because of the high quality of leadership, knowledge, and compassion I witnessed while working with Jennifer. Handling SAU matters in the juvenile division is challenging because the cases often feature a victim and an alleged offender who are immediate family. There is trauma, worry and confusion about what a court case will be like. I felt confident working with Jennifer on these cases. During our victim meetings Jennifer would warmly offer a clear and direct description of the relevant legal issues, as well as explain the process and her role as deputy prosecuting attorney. For most of the families we worked with this was their first involvement with the legal system. She would listen carefully to their questions and comments and take them into consideration when making her decisions. In particular, her respectful demeanor and clear language was very helpful to these families. She would explain that rehabilitation was a goal in the juvenile division. She would also give information about alternatives to prosecution. We served families of many backgrounds: married and divorced, longtime Snohomish County residents and recent immigrants, families with young children and families with teenagers, as well as families from the LGBTQ+ community. Jennifer related well to the wide variety of people we served.

Prior to my assignment in the juvenile division I was a victim/witness advocate in district court. Based on my experience I believe that Jennifer will be an excellent district court judge. Most of the people I saw in district court were there because of some poor judgement, lack of planning, lack of resources, or they made a bad decision one day that ended with police involvement. Coming before a judge can be a pivotal moment. I believe that Jennifer will be a fair, compassionate, consistent presence on the bench. She will offer leadership not only to the people in the room, but also to the entire community.

As Snohomish County struggles with homelessness, impacts of substance use disorder, and mental illness our courts can be an important pivot point, guiding people toward treatment and resources. When I worked with Jennifer I saw her value each person and each case. I watched her work with defense attorneys, probation, court staff and the staff in our office, and she was always well prepared. I feel confident she will bring a tremendous skillset to Cascade District Court.
