# PROPOSED ORDINANCE NO. 24-110

### APPROVING DATA SHARING AGREEMENT WITH WASHINGTON STATE DEPARTMENT OF HEALTH FOR CONFIDENTIAL INFORMATION OR LIMITED DATASETS

**Background:** The ordinance approves a data sharing agreement with the Washington State Department of Health to access the CDC National Syndromic Surveillance Program (NSSP) Electronic Surveillance System for the Early Notification of Community-based Epidemics (ESSENCE) platform. ESSENCE contains syndromic surveillance data from Washington and other participating states and includes analytical tools with which authorized users may interact with the data. ESSENCE data is used to identify and respond quickly to public health threats such as novel pathogens, as well as track injury and health condition trends, evaluate interventions implemented, and assists local health jurisdictions with providing quality public health services.

At the Public Hearing, the Council may consider amendments to the proposed ordinance.
