Currently direct supervisor for Homeward House Collaborative a program serving parents and infants affected by the Opioid epidemic (and other substance abuse) and at risk or involved with the child-welfare services; Parents For Parents a mentorship program for parents involved in a court dependency case; Landlord Engagement Project reaching to landlords and helping hard to place families and individuals to secure rental units and the Data Team. And 6 years' experience as Domestic Violence Children's Advocate (3 with DVS), 3 years pre-school education and 10 years as Kindergarten Teacher
