Consideration:

The proposed motion would authorize the County Executive to sign Supplement No. 4 to the professional services agreement CCF01-21 with Sargent Engineers, Inc. to provide structural design services for the Goodman Creek Culvert Replacement Project, pursuant to SCC 3.04.190.

Background:

The Department of Public Works needs to replace the existing Goodman Creek Culvert with a new bridge. Upon investigation it was discovered that the existing 12-inch diameter corrugated metal culvert had rusted, allowing for partial flow beneath the roadway, creating voids. Through the Requests for Qualifications process (RFQ-006-20SB), Public Works selected Sargent Engineers, Inc. following all established Federal, State and County policies and practices.

Phase I of the project has been completed, which included complete investigations, research, analysis, and calculations required for the preparation of a Type, Size and Location Study (TS&L). Public Works is ready to begin Phase II of the project, which includes final bridge design plans, specifications, estimates, and assistance during bidding and construction related design support services.

Current Proposal:

Scope: Approval by motion is sought from Council to authorize the County Executive to sign Supplement No. 4 to the agreement with Sargent Engineers, Inc.

Duration: The term of this contract is from execution to December 31, 2022 unless terminated in accordance with Section VII of the contract.

Fiscal Implications: The total amount payable under this agreement is not to exceed \$206,115.00. (Total amended amount not to exceed \$302,386.00)
