**Summary:** The ordinance approves an Interlocal Agreement (ILA) to cover year-round fire protection and emergency response services for public health, safety and welfare of the Fairgrounds property and the annual Evergreen State Fair. The County Fairgrounds does not pay property taxes, thus the ILA is the most economical and efficient means in providing fire and emergency services to County owned property and activities. The ILA is for a one-year term ending December 31, 2023, at a cost of \$41,253.14 for year-round fire protection and \$42,411.70 for fair services during the annual Evergreen State Fair. The total cost for the County is not to exceed \$83,664.84 for 2023.
