

AMENDMENT 3 TO THE SERVICES AGREEMENT WITH AMERICAN PLATFORM SERVICES, AN ARIZONA LLC., DBA THERECORDXCHANGE

This Amendment 3 to the "Services Agreement," (the "Master Agreement"), executed on August 10, 2022, as amended by Amendment 1 dated October 28, 2022, and Amendment 2 dated March 20, 2024 (together, hereafter "the Agreement"), by and between Snohomish County, a political subdivision of the State of Washington (the "County") and American Platform Services, an Arizona LLC., d/b/a TheRecordXchange, duly registered and authorized to conduct business in Washington State (the "Contractor") is made and entered into on this _____ day of _____, 2025.

RECITALS

WHEREAS, the County and American Platform Services, an Arizona LLC., d/b/a TheRecordXchange (the "Contractor") are the parties to that certain Agreement to design, deploy and configure a cloud-based customized web portal for District Court for capturing and fulfilling requests for public access to digital court recordings captured by the ExhibitOne platform; and

WHEREAS, the current term of the Agreement ends July 31, 2025; and

WHEREAS, competition is waived in accordance with Snohomish County Code 3.04.202(7); and

WHEREAS, the parties wish to amend the Agreement to renew automatically each year on the anniversary date unless terminated by the County in accordance with the Agreement; and

WHEREAS, the parties have agreed to an annual increase of four (4) percent beginning August 1, 2025.

NOW, THEREFORE, for and consideration of the mutual benefits conferred on both parties, the parties agree as follows:

1. Section III. Term is amended to read as follows:

The term of this Agreement shall begin June 1, 2022 and, beginning August 1, 2025, shall renew automatically each year unless terminated in accordance with the Agreement.

2. Subsection 4.01.2, is hereby added to the Agreement as follows:

4.01.2 Beginning August 1, 2025, and on the annual anniversary date thereafter, the annual fee, as set forth in Subsection 4.01.1, shall increase by four (4) percent.

3. All other terms of the Master Agreement shall remain in full force and effect, except as expressly modified by this Amendment 3.


