Section 1. Snohomish County Code Section 2.300.090, adopted by Amended Ordinance No. 22-061 on October 26, 2022, is amended to read:

There is hereby established a Snohomish county board of health, as directed by RCW 70.05.035. The board of health shall annually elect a chair and vice chair from its membership (~~in January of each year~~). The chair shall be one of the county councilmembers and shall preside at the meetings of the board of health.
