Subject: Amendment No. 2 to Agreement for Access to Baby and Child Dentistry (ABCD)

Scope: Amendment No. 2 to the contract with the Washington State Health Care Authority for Access to Baby and Child Dentistry Services increases the not to exceed amount by \$150,576, bringing the contract total to \$363,152. Additionally, the amendment extends the contract period through June 30, 2028.

The amendment also replaces the Statement of Work. Additions to the statement of work include:

- Maintain an up-to-date website
- Coordinate program communication with DentistLink to support participating dental practices and maintain accurate program information
- Collect information from dentist roster regarding language and translation services, capability of serving children with disabilities and special health care needs, and General Anesthesia availability.
- ABCD Coordinators are required to meet the expectations defined in an ABCD toolkit.

Amendment No. 2 adds Attachment 5: ABCD Action Plan to the contract. The attachment provides a template for the development of SMART goals.

Council approval of the amendment is required pursuant to Snohomish County Code 4.26.025(2).

Authority Granted: Motion 26-198 authorizes the Executive to sign Amendment No. 2 with Washington State Health Care Authority to provide Access to Baby and Child Dentistry (ABCD) services.

Background: Access to Baby and Child Dentistry services detect and prevent early childhood dental decay by engaging dentists in seeing eligible Apple Health/Medicaid clients. Snohomish County receives grant funds from the Health Care Authority to conduct outreach for this program and maintain a roster of dentists providing these services.

On November 5, 2025, Council approved the 2026 Health Department Grant Work Plan via Motion 25-452¹. The plan includes a grant from the Health Care authority for Access to Baby and Child Dentistry (ABCD) in the amount of \$212,576. This grant was also included in the Health Department Grant Work Plans for 2024² and 2025³.

On July 9, 2024, the Director of the Health Department executed an agreement with the Health Care Authority for Access to Baby and Child Dentistry services in the amount of \$150,576.

On November 27, 2024, Council approved Amendment 1 to the agreement for ABCD services via Motion 24-360. This amendment authorized an increase of \$62,000, bringing the contract total to \$212,576.
