This is a binding Agreement entered into by and between the state of Washington, Department of Ecology, hereinafter referred to as "ECOLOGY," and Snohomish County, hereinafter referred to as the "RECIPIENT," to carry out with the provided funds activities described herein.

Project Type: NEP Stormwater Strategic Initiative 2.0

Project Short Description:

Snohomish County (the RECIPIENT) at Evergreen State Fairgrounds Park will implement a feasibility study resulting in preliminary designs of Best Management Practices (BMP) for a new French Creek channel to route wetland flow through the Fairgrounds isolated from stormwater collection systems. The completed design will include recommendations for an interpretive program for public education for ongoing efforts to restore habitat and how this project addresses factors of climate resiliency.

Project Long Description:

Snohomish County (RECIPIENT) is implementing a feasibility study and design project at the Evergreen State Fairgrounds Park. The project will create preliminary engineering designs of BMP to address the current ineffective stormwater infrastructure and pollution of natural drainage contaminating French Creek and an un-named tributary. The project site receives surface flow from off-site subbasins to a 25-acre wetland on site which are comingled before being

routed off-site. Surface water flows are contaminated by runoff from diverse uses including livestock areas, a motorsports track, carnival and recreation vehicles areas with both paved and dirt surfaces.

The commingled water has put stress on existing infrastructure resulting in flooding throughout the property.

The RECIPIENT will conduct feasibility studies and design a BMP to address two issues with the stormwater system.

- Stream Daylighting RECIPIENT will conduct a feasibility study and design a new surface water channel to route wetland flow through the park property isolated from the existing stormwater collection system.
- Stormwater Collection Vault RECIPIENT will design a retrofit for the existing inadequate stormwater infrastructure with BMP that enhance flow control, isolate, and collect surface water runoff for retention and treatment before discharging from the property.

These designs will divert significant amounts of flow from the storm system, allow for cost-effective stormwater treatment, improve the water quality of French Creek, restore historic salmonid habitat, and offer educational opportunities for visitors. Retrofitting the existing infrastructure will improve the ecological and hydrological health of the off-site creek, enhance flood resiliency, and reduce hydrologic impacts to the French Creek basin.

Preliminary design will include the RECIPIENT implementing data collection to assess current site conditions including: geotechnical analysis, water quality monitoring, topographic surveying, and stormwater infrastructure assessment. The RECIPIENT will also prepare environmental documentation, identify design, engineering criteria, and environmental standards for future design development, compliance with codes, and permitting requirements including cultural resources review, a wetland delineation and critical areas assessment, a flood risk assessment, and an environmental justice report.

During the design process, the RECIPIENT will provide community planning partners with regular updates and opportunities for input on the proposed elements of the design utilizing citizen action groups identified during development of the Snohomish County Parks 'Preferred Plan'. The Preferred Plan elements were developed with feedback from the public, including over 1,700 community comments from online surveys and public meetings. The RECIPIENT will continue to engage with the community throughout development by creating an outreach program which solicits and incorporates community inputs into the design work. Input from the community will be circulated to project partners before being folded into BMP designs. Designs will include an interpretive program to inform the public about efforts to restore salmon habitat and preliminary recommendations for public use of the area created by the development of a retention vault.

Overall Goal:

This PROJECT will:

- Develop preliminary BMP designs that eliminate pollutants in natural surface waters that come from commingling of surface water with contaminated fairground site runoff.
- Assess current water quality and volume of surface water movement through the site with Geotech, Topographic, and Water Quality assessments.
- Produce and socialize an alternatives analysis report, presented during both the quarterly partner meetings and community meetings. Create a report and executive leadership briefing on the design alternatives.
- Create a final report and 30% design. The design will serve as the basis for: construction grant funding applications, establishing footprint changes to the fair park, promote robust public outreach and input into design of public space, and serve as the basis for construction permit applications.

1.1 QUALITY ASSURANCE PROJECT PLAN (QAPP) DEVELOPMENT

Work related to data collection or analysis may not begin until the Quality Assurance Project Plan (QAPP) is approved by the Washington State Department of Ecology's National Estuary Program Quality Coordinator (NEP QC) or the NEP QC provides written documentation that a QAPP is not required.

Per EPA sub-award terms and conditions, for projects that involve the collection, production, evaluation, or use of environmental information, the RECIPIENT must submit a Quality Assurance Project Plan (QAPP) to the Washington State Department of Ecology's NEP Quality Coordinator (NEP QC) using EPA's NEP guidance for QAPPs. Project work should not begin until the Quality Assurance Project Plan (QAPP) has Quality Assurance approval. Cultural Resources Review may take up to 45–60 days to complete.

Task Title: Data Collection

Task Description:

After completion of Tasks 1.1 and 1.2, the RECIPIENT will collect data on site conditions to provide a baseline assessment for developing preliminary BMP designs for retrofitting and developing new stormwater infrastructure and surface water management. Data collection will include geotechnical analysis to assess infiltration rates and groundwater elevation, water quality monitoring to identify pollutants at the site, and a topographic survey to provide accurate design elevations for the open conveyance channel and fish-passable culverts.

3.1 GEOTECHNICAL EXPLORATIONS

Following completion of Tasks 1.1 and 1.2, the RECIPIENT will assess the structural and infiltration characteristics of the soil in the proposed work area in a Geotechnical Memorandum. The work will include utilizing borings and piezometers for each of the subbasins, to establish design infiltration rates, soil properties, and seasonal groundwater levels.

ECOLOGY (ECY) will have 30 days to provide feedback and comments on the memorandum.

3.2 WATER QUALITY MONITORING PROGRAM & DRAFT SUMMARY

The RECIPIENT will develop and implement a water quality monitoring program. This program will include stormwater sampling to identify pollutants present at the site, along with hydrologic and hydraulic (H&H) modeling to quantify the volume of stormwater runoff needing treatment. It will be used during the design phase to meet applicable treatment standards. The H&H modeling will look at both the stormwater runoff and the flow from the unnamed tributary to French Creek to assess both current and future flows. The modeled flow rates will be used during design to size the stormwater treatment flow rates before they are re-introduced to the unnamed tributary to French Creek at the downstream end of the project.

The RECIPIENT will create a Draft Water Quality Monitoring Summary analyzing one year of results, including quarterly

The RECIPIENT will create a Draft Water Quality Monitoring Summary analyzing one year of results, including quarterly sampling and monitoring events. ECY will have 30 days to provide feedback on the final summary.

3.3 FINAL WATER QUALITY MONITORING SUMMARY

The RECIPIENT will incorporate ECY's and partner feedback from the Draft into a Final Water Quality Monitoring Summary. ECY will have 30 days to provide feedback on the final summary.

3.4 TOPOGRAPHIC SURVEY MAP

The RECIPIENT will use aerial mapping and ground-based survey to develop a topographic base map of the project area. This will provide the reference surface for concept engineering. The base map will provide 1-foot contours and the extent of key features. It will capture roads, buildings, storm system infrastructure, walls, drainage features, and critical area boundaries.

3.5 EXISTING STORMWATER INFRASTRUCTURE MAPPING AND CONDITION ASSESSMENT

The RECIPIENT will prepare a pipe assessment matrix identifying faulty pipes, proposed repairs, and planning-level cost estimates for each repair. This assessment will be used to evaluate current conditions and their impact on proposed design elements and facilitate design of stormwater separation infrastructure. The stream daylighting project will utilize this data to avoid comingling elements of site surface water runoff with the new creek, while the retention vault will utilize this data to create optimized flow of contaminated water into separate retention and treatment infrastructure.

Task Title: Environmental Documentation

Task Description:

The RECIPIENT will complete environmental documentation for the site including wetland delineation with a Critical Areas Report, preparing a Cultural Resources Report in coordination with the Tulalip Tribe, performing hydrologic and hydraulic analysis with report, GIS modeling, and an Environmental Justice Report.

4.1 PERMIT SUPPORT

The RECIPIENT will prepare documentation needed to apply for permits for the surface water separation project, identifying permitting requirements and anticipated timelines. Permit applications will not be submitted during the conceptual design phase funded by this subaward. The RECIPIENT will retain professional services to conduct required field studies and code review to confirm permitting requirements and prepare technical documentation required to support permit applications.

The RECIPIENT will provide a matrix of permit requirements and supporting documentation that can be used in future phases.

4.2 CRITICAL AREAS AND HABITAT ASSESSMENT

ECY will have 30 days to review and provide feedback.

The RECIPIENT will identify critical areas and habitat within the project area through GIS research and ground reconnaissance. The RECIPIENT will perform a formal wetland delineation, meeting the Army Corps of Engineers methodology, providing flagging of wetland boundaries for the surveyor to add to the project base map.

The RECIPIENT will provide a Wetlands Critical Area Report and documentation supporting the addressing of steep slopes or other critical areas identified in the project area. ECY will have 30 days to review and provide feedback.

4.3 CULTURAL RESOURCES REPORT

The RECIPIENT will complete a cultural resource screening of the project area for information about previous cultural resources assessments in the project vicinity and identified archeological sites. The RECIPIENT will work with a professional archeologist to conduct a survey of the project area, contacting the Tulalip Tribe to inform them of the survey and inviting them to attend prior to doing so. The archeologist will prepare a report that will include a brief description of the project, a summary of background research, and an assessment of the project's potential for affecting buried pre-contact or historical archeological sites. The report will be suitable for ECY's submission to DAHP and affected Tribes.

4.4 FLOOD RISK ASSESSMENT

The RECIPIENT will assess the flood risk created by the project. The site lies outside the floodplain but proposes to daylight a stream, which will change local hydrology. The assessment will consider risk to public safety and property. The RECIPIENT will include the Flood Risk Assessment in the Hydraulic Report.

4.5 ENVIRONMENTAL JUSTICE REPORT

The RECIPIENT may create an Environmental Justice Report. Likely analysis required by the contractor will include GIS modeling and review of reporting from similar projects.

If created, the RECIPIENT will provide a copy of the Environmental Justice Report. ECY will have 30 days to review and provide feedback.

Appeals of the Director's decision will be brought in the Superior Court of Thurston County. Review of the Director's decision will not be taken to Environmental and Land Use Hearings Office.

Pending final decision of a dispute, the RECIPIENT agrees to proceed diligently with the performance of this Agreement and in accordance with the decision rendered.

Nothing in this Agreement will be construed to limit the parties' choice of another mutually acceptable method, in addition to the dispute resolution procedure outlined above.

12. ENVIRONMENTAL DATA STANDARDS

- a) RECIPIENT shall prepare a Quality Assurance Project Plan (QAPP) for a project that collects or uses environmental measurement data. RECIPIENTS unsure about whether a QAPP is required for their project shall contact the ECOLOGY Program issuing the grant or loan. If a QAPP is required, the RECIPIENT shall:
- Use ECOLOGY's QAPP Template/Checklist provided by the ECOLOGY, unless ECOLOGY Quality Assurance (QA) officer or the Program QA coordinator instructs otherwise.
- Follow ECOLOGY's Guidelines for Preparing Quality Assurance Project Plans for Environmental Studies, July 2004 (Ecology Publication No. 04-03-030).
- Submit the QAPP to ECOLOGY for review and approval before the start of the work.
- b) RECIPIENT shall submit environmental data that was collected on a project to ECOLOGY using the Environmental Information Management system (EIM), unless the ECOLOGY Program instructs otherwise. The RECIPIENT must confirm with ECOLOGY that complete and correct data was successfully loaded into EIM, find instructions at: http://www.ecy.wa.gov/eim.
- c) RECIPIENT shall follow ECOLOGY's data standards when Geographic Information System (GIS) data is collected and processed. Guidelines for Creating and Accessing GIS Data are available at:

https://ecology.wa.gov/Research-Data/Data-resources/Geographic-Information-Systems-GIS/Standards. RECIPIENT, when requested by ECOLOGY, shall provide copies to ECOLOGY of all final GIS data layers, imagery, related tables, raw data collection files, map products, and all metadata and project documentation.

13. GOVERNING LAW

This Agreement will be governed by the laws of the State of Washington, and the venue of any action brought hereunder will be in the Superior Court of Thurston County.

14. INDEMNIFICATION

ECOLOGY will in no way be held responsible for payment of salaries, consultant's fees, and other costs related to the project described herein, except as provided in the Scope of Work.

To the extent that the Constitution and laws of the State of Washington permit, each party will indemnify and hold the other harmless from and against any liability for any or all injuries to persons or property arising from the negligent act or omission of that party or that party's agents or employees arising out of this Agreement.

15. INDEPENDENT STATUS

The employees, volunteers, or agents of each party who are engaged in the performance of this Agreement will continue to be employees, volunteers, or agents of that party and will not for any purpose be employees, volunteers, or agents of the other party.

19. PRESENTATION AND PROMOTIONAL MATERIALS

ECOLOGY reserves the right to approve RECIPIENT's communication documents and materials related to the fulfillment of this Agreement:

- a) If requested, RECIPIENT shall provide a draft copy to ECOLOGY for review and approval ten (10) business days prior to production and distribution.
- b) RECIPIENT shall include time for ECOLOGY's review and approval process in their project timeline.
- c) If requested, RECIPIENT shall provide ECOLOGY two (2) final copies and an electronic copy of any tangible products developed.

Copies include any printed materials, and all tangible products developed such as brochures, manuals, pamphlets, videos, audio tapes, CDs, curriculum, posters, media announcements, or gadgets with a message, such as a refrigerator magnet, and any online communications, such as web pages, blogs, and twitter campaigns. If it is not practical to provide a copy, then the RECIPIENT shall provide a description (photographs, drawings, printouts, etc.) that best represents the item.

- a) RECIPIENT must satisfactorily demonstrate the timely use of funds by submitting payment requests and progress reports to ECOLOGY. ECOLOGY reserves the right to amend or terminate this Agreement if the RECIPIENT does not document timely use of funds.
- b) RECIPIENT must submit a progress report with each payment request. Payment requests will not be processed without a progress report. ECOLOGY will define the elements and frequency of progress reports.
- c) RECIPIENT shall use ECOLOGY's provided progress report format.
- d) Quarterly progress reports will cover the periods from January 1 through March 31, April 1 through June 30, July 1 through September 30, and October 1 through December 31. Reports shall be submitted within thirty (30) days after the end of the quarter being reported.
- e) RECIPIENT must submit within thirty (30) days of the expiration date of the project, unless an extension has been approved by ECOLOGY, all financial, performance, and other reports required by the Agreement and funding program guidelines. RECIPIENT shall use the ECOLOGY provided closeout report format.

21. PROPERTY RIGHTS

- a) Copyrights and Patents. When the RECIPIENT creates any copyrightable materials or invents any patentable property under this Agreement, the RECIPIENT may copyright or patent the same but ECOLOGY retains a royalty free, nonexclusive, and irrevocable license to reproduce, publish, recover, or otherwise use the material(s) or property, and to authorize others to use the same for federal, state, or local government purposes.
- b) Publications. When the RECIPIENT or persons employed by the RECIPIENT use or publish ECOLOGY information; present papers, lectures, or seminars involving information supplied by ECOLOGY; or use logos, reports, maps, or other data in printed reports, signs, brochures, pamphlets, etc., appropriate credit shall be given to ECOLOGY.
- c) Presentation and Promotional Materials. ECOLOGY shall have the right to use or reproduce any printed or graphic materials produced in fulfillment of this Agreement, in any manner ECOLOGY deems appropriate. ECOLOGY shall acknowledge the RECIPIENT as the sole copyright owner in every use or reproduction of the materials.
- d) Tangible Property Rights. - g) Conversions. Such approval may be conditioned upon payment to ECOLOGY of that portion of the proceeds of the sale, lease, or other conversion or encumbrance which monies granted pursuant to this Agreement bear to the total acquisition, purchase, or construction costs of such property.

22. RECORDS, AUDITS, AND INSPECTIONS

RECIPIENT shall maintain complete program and financial records relating to this Agreement, including any engineering documentation and field inspection reports of all construction work accomplished.

All records shall:

- a) Be kept in a manner which provides an audit trail for all expenditures.
- b) Be kept in a common file to facilitate audits and inspections.
- c) Clearly indicate total receipts and expenditures related to this Agreement.
- d) Be open for audit or inspection by ECOLOGY, or by any duly authorized audit representative of the State of Washington, for a period of at least three (3) years after the final grant payment or loan repayment, or any dispute resolution hereunder. RECIPIENT shall provide clarification and make necessary adjustments if any audits or inspections identify discrepancies in the records.

ECOLOGY reserves the right to audit, or have a designated third party audit, applicable records to ensure that the state has been properly invoiced. Any remedies and penalties allowed by law to recover monies determined owed will be enforced. Repetitive instances of incorrect invoicing or inadequate records may be considered cause for termination.

All work performed under this Agreement and any property and equipment purchased shall be made available to ECOLOGY and to any authorized state, federal or local representative for inspection at any time during the course of this Agreement and for at least three (3) years following grant or loan termination or dispute resolution hereunder.

RECIPIENT shall provide right of access to ECOLOGY, or any other authorized representative, at all reasonable times, in order to monitor and evaluate performance, compliance, and any other conditions under this Agreement.

23. RECOVERY OF FUNDS

The right of the RECIPIENT to retain monies received as reimbursement payments is contingent upon satisfactory performance of this Agreement and completion of the work described in the Scope of Work.

All payments to the RECIPIENT are subject to approval and audit by ECOLOGY, and any unauthorized expenditure(s) or unallowable cost charged to this Agreement shall be refunded to ECOLOGY by the RECIPIENT.

RECIPIENT shall refund to ECOLOGY the full amount of any erroneous payment or overpayment under this Agreement. RECIPIENT shall refund by check payable to ECOLOGY the amount of any such reduction of payments or repayments within thirty (30) days of a written notice. Interest will accrue at the rate of twelve percent (12%) per year from the time ECOLOGY demands repayment of funds.

Any property acquired under this Agreement, at the option of ECOLOGY, may become ECOLOGY's property and the RECIPIENT's liability to repay monies will be reduced by an amount reflecting the fair value of such property.

24. SEVERABILITY

If any provision of this Agreement or any provision of any document incorporated by reference shall be held invalid, such invalidity shall not affect the other provisions of this Agreement which can be given effect without the invalid provision, and to this end the provisions of this Agreement are declared to be severable.

25. STATE ENVIRONMENTAL POLICY ACT (SEPA)

RECIPIENT must demonstrate to ECOLOGY's satisfaction that compliance with the requirements of the State Environmental Policy Act (Chapter 43.21C RCW and Chapter 197-11 WAC) have been or will be met. Any reimbursements are subject to this provision.

26. SUSPENSION

When in the best interest of ECOLOGY, ECOLOGY may at any time, and without cause, suspend this Agreement or any portion thereof for a temporary period by written notice from ECOLOGY to the RECIPIENT. RECIPIENT shall resume performance on the next business day following the suspension period unless another day is specified by ECOLOGY.

28. TERMINATION

a) For Cause

ECOLOGY may terminate for cause this Agreement with a seven (7) calendar days prior written notification to the RECIPIENT, at the sole discretion of ECOLOGY, for failing to perform an Agreement requirement or for a material breach of any term or condition. If this Agreement is so terminated, the parties shall be liable only for performance rendered or costs incurred in accordance with the terms of this Agreement prior to the effective date of termination.

Failure to Commence Work. ECOLOGY reserves the right to terminate this Agreement if RECIPIENT fails to commence work on the project funded within four (4) months after the effective date of this Agreement, or by any date mutually agreed upon in writing for commencement of work, or the time period defined within the Scope of Work.

Non-Performance. The obligation of ECOLOGY to the RECIPIENT is contingent upon satisfactory performance by the RECIPIENT of all of its obligations under this Agreement. In the event the RECIPIENT unjustifiably fails, in the opinion of ECOLOGY, to perform any obligation required of it by this Agreement, ECOLOGY may refuse to pay any further funds, terminate in whole or in part this Agreement, and exercise any other rights under this Agreement.

Despite the above, the RECIPIENT shall not be relieved of any liability to ECOLOGY for damages sustained by ECOLOGY and the State of Washington because of any breach of this Agreement by the RECIPIENT. ECOLOGY may withhold payments for the purpose of setoff until such time as the exact amount of damages due ECOLOGY from the RECIPIENT is determined.

b) For Convenience

ECOLOGY may terminate for convenience this Agreement, in whole or in part, for any reason when it is the best interest of ECOLOGY, with a thirty (30) calendar days prior written notification to the RECIPIENT, except as noted below. If this Agreement is so terminated, the parties shall be liable only for performance rendered or costs incurred in accordance with the terms of this Agreement prior to the effective date of termination.

Non-Allocation of Funds. ECOLOGY's ability to make payments is contingent on availability of funding. In the event funding from state, federal or other sources is withdrawn, reduced, or limited in any way after the effective date and prior to the completion or expiration date of this Agreement, ECOLOGY, at its sole discretion, may elect to terminate the Agreement, in whole or part, or renegotiate the Agreement, subject to new funding limitations or conditions. ECOLOGY may also elect to suspend performance of the Agreement until ECOLOGY determines the funding insufficiency is resolved. ECOLOGY may exercise any of these options with no notification or restrictions, although ECOLOGY will make a reasonable attempt to provide notice.

In the event of termination or suspension, ECOLOGY will reimburse eligible costs incurred by the RECIPIENT through the effective date of termination or suspension. Reimbursed costs must be agreed to by ECOLOGY and the RECIPIENT. In no

event shall ECOLOGY's reimbursement exceed ECOLOGY's total responsibility under the Agreement and any amendments. c) By Mutual Agreement

ECOLOGY and the RECIPIENT may terminate this Agreement, in whole or in part, at any time, by mutual written agreement.

d) In Event of Termination

All finished or unfinished documents, data studies, surveys, drawings, maps, models, photographs, reports or other materials prepared by the RECIPIENT under this Agreement, at the option of ECOLOGY, will become property of ECOLOGY and the RECIPIENT shall be entitled to receive just and equitable compensation for any satisfactory work completed on such documents and other materials.

Nothing contained herein shall preclude ECOLOGY from demanding repayment of all funds paid to the RECIPIENT in accordance with Recovery of Funds, identified herein.

29. THIRD PARTY BENEFICIARY

RECIPIENT shall ensure that in all subcontracts entered into by the RECIPIENT pursuant to this Agreement, the state of Washington is named as an express third party beneficiary of such subcontracts with full rights as such.

30. WAIVER

Waiver of a default or breach of any provision of this Agreement is not a waiver of any subsequent default or breach, and will not be construed as a modification of the terms of this Agreement unless stated as such in writing by the authorized representative of ECOLOGY.
