- (5) Snohomish County will not be held liable for Data Security through the Provided VPN facility.
- (6) Snohomish County will not be held liable for failures in the Communications link across the internet once the traffic has left Snohomish County's Internet point of Presence.

1. Overview

The Ascend Web implementation at Snohomish County involves the installation of two Manatron modules, Ascend Web (Inquiry) and Statement Server. The objective of the project is to provide the Treasurer's office with the following capabilities:

- To provide public access to property tax and payment information via the Internet.
- To provide secure access to tax service firms (e.g. title companies) for more detailed property information as determined by the County.
- To provide an option for the Treasurer's office to submit Real Estate Excise Tax (REET) information to the Department of Revenue electronically.

In this implementation, no taxpayer banking information will be collected on Snohomish County's website. Items to be paid will be determined by the taxpayer and those amounts will be passed through to the County's bank where the financial transaction will be performed. Updates to Ascend for payment information will be performed via batch processing already in use at the County.

2. Project Information

Project management, configuration, implementation services and testing of Ascend Web & Statement Server will be performed at Manatron offices in Bellevue, WA. Any additional requirements will gathered primarily through teleconferencing supplemented by on-site visits to Snohomish County if needed although none are contemplated at this time. Project management and coordination will also be conducted through teleconferencing. User acceptance testing and

• Statement tables purge / performance options must be provided due to the Ascend Web product design reliance upon writing interim statement calculation records, with no further use or plan for deletion after the Ascend Web inquiries are completed using these records. Manatron will develop a query to delete all Ascend Web created records created by Process ID Bselfast and without turning logging off, run in an Access program or from the Ascend Application by end users. To run with logging on, it may be necessary to delete no more than 200,000 records at a time. This purge process to delete all Ascend Web originated records on a periodic, monthly or weekly basis, etc. would delete all Ascend Web written Ascend table records. This would include but not be limited to



deletion of records created by Ascend Web in the following Ascend tables and any other tables for which Ascend Web may write records.

SQL Server Database Migration Project Statement of Work

SNOHOMISH COUNTY AND MANATRON

Phase 1

The purpose of this project is to convert Snohomish County's Ascend and ProVal applications from an Informix based database platform, to an SQL Server based database platform. Manatron will provide software, analyst consulting time and assistance, and customer support time and assistance to facilitate the complete and accurate migration of data, and to provide a working set of application software and integration services for this project.

Areas of Work

The areas of work that will be covered by the project are listed below. The party responsibilities for these areas are described in this document.

- 1.) Conversion Scripts
- 2.) Data Cleansing
- 3.) Data Validation
- 4.) Template Schemas
- 5.) Security Configuration
- 6.) Updated Application Installation
- 7.) Migration Completion Assurance
- 8.) Non-Standard and Custom County Database Objects
- 9.) Web Servers and Service Processes
- 10.) Account Detail Validations
- 11.) Hardware, Software and Remote Connectivity Resources
- 12.) Data Availability
- 13.) Database and Application Versions
- 14.) Support Coordination

Strategy

Manatron recommends that the conversion of both the Ascend and ProVal applications happen simultaneously, using methods developed by Manatron in order to maintain data consistency and provide a more timely turnaround of the trial and final conversion data migrations.

Manatron will provide general assistance and software tools, scripts and analyst services, and will perform the first conversion with county staff assistance. It is expected that the County will perform the second, any additional conversion trials, and the final cutover conversion process.

Integration

It is expected that the integration procedures, processes and schema objects used in the Informix version of the customer's database, used to enable data integration, sharing, and shipping between Ascend and ProVal, will be tested and maintained in an equivalent fashion on the migrated version of the customer's database.

Notification

It is expected that the County will perform its testing responsibilities in a timely fashion, and will notify the appropriate Manatron resource of any errors, deficiencies or issues with the conversion or final migration databases or applications. Some deficiencies may need to be remedied through normal customer support channels, which may generate a successful solution on a subsequent version of each provider's (Ascend or ProVal) software. Manatron may provide a 'pre-release' version of the software remedy at its discretion. All system functions relied on to work for County Assessor & Treasurer line-of-business uses will be functional at time of migration, or handled as a stop-work issue when reported to Manatron.

* The Manatron Project Manager will have the overall responsibility for successful delivery of the project. Serving as the single point-of-contact for the client, the Manatron Project Manager is responsible for supervision of the implementation from initiation through project close.

The Manatron Project Manager and the County Project Managerwill discuss project status on a regular basis, as mutually agreed. The meeting intervals (typically weekly or bi-weekly) will be determined at project kickoff. Both the Manatron and the Snohomish County Project Manager will contribute a list of agenda topics to the regularly scheduled meeting.

In addition to regular communication with the client, the project manger's responsibilities also include managing the processes for change control, business process change, project organization and the tracking of deliverables, issues and project risks. Projects are managed with consideration of schedule, requirements, budget and quality to obtain effective use of time, resources and money.

Upon go-live, the project manager will transition the project to our support organization to assist with first year business cycle and manage ongoing expectations. Typically this transition occurs within 30 days after go-live, but the timing can be extended to something mutually agreed upon by both parties.

Manatron's compensation under this contract, is set forth above and will be invoiced per the Acceptance Criteria and Billing Milestones outlined below and contained in the Acceptance Criteria documents on pages 14 – 16 of this SOW:

- a. \$24,000 for client license components (Querix 100 seats + annual support) following acceptance of Acceptance Criteria #1 Phase I Project Initiation on page 13-14.
- b. \$38,500 following acceptance of Acceptance Criteria #2 Phase II 1ST Migration, Test Client Configuration and Initial Migration Testing on page 15.
- c. \$38,500 following acceptance of Acceptance Criteria #3 Phase III Final Migration and Testing for Production Cutover on page 16.
- d. Professional Services fees are due and payable after Manatron performs such services in accordance Agreement #: WA4212011SC Page 2 of 17

with Manatron's invoice(s) that shall be sent to the Customer. No travel is expected.

e. All invoices are due Net Thirty (30)-Days from receipt of invoice and following successful completion and County acceptance of the milestone deliverables described elsewhere in this document.

Ascend/ProVal Informix to SQL Server Migration Guide

Currently supported Migration paths:

Informix Platforms: IDS 10.x and IDS 11.x.

SQL Server Platforms:SQL Server 2005 and SQL Server 2008r2 in 2005 compatibility modeAscend Schema Versions:Ascend Release 3.6 HP5 minimum, preference is to migrate on latestAscend release.ProVal Schema Versions:ProVal Schema Versions:ProVal 7.82 minimum

General Procedure Outline:

- 1.) Ascend/ProVal Data is captured from the Source Migration Database at the customer's location. A script will be provided that will first check for date/boundary issues, and will provide a list of updates that may need to be run. The script will also perform some date formatting, so that the data can be imported to SQL Server.
- 2.) Data will be unloaded to data files, using the MANATRON-provided script.
- 3.) A 'transformation' routine will need to be created to prepare the data files for loading to SQL Server. The machine storing the data files will need to have Cygwin loaded, and MANATRON will provide a command file that will run the processing. Each file will be copied, processed, and output with a different file extension.
- 4.) A spreadsheet with a list of files and the tables associated with them will be provided by MANATRON. It may need some updating by the customer for a few location specific files. This spreadsheet will create a list of 'Bulk Insert' commands to be run from an SQL Server utility program.
- 5.) A new Ascend and ProVal schema for SQL Server will be provided by MANATRON. The Ascend/ProVal versions of the Source and Target schemas will need to be synchronized. MANATRON will provide content for new SQL Server specific configuration tables which must be created with initial data for the migration.
- 6.) When the Target schema is available, the Bulk Insert program will load the processed data files into the new SQL Server schema.
- 7.) When all data files have been loaded, the bulk of the migration is complete.
- 8.) MANATRON will provide a script that will create indexes and statistics after the data has been loaded.
- 9.) The customer will need a new set of Ascend Client code (recompiled version for use with Querix), and a Querix runtime installation installed on a client workstation to test connections to the new SQL Server Ascend database. The existing ProVal application should work with the migrated data, but will need new preferences and connection data configured. Permissions and authentication methods will need to be established on the new SQL Server database instance.

Post Migration Verification and Validations:

Some stored data values will need to be verified after the migration. MANATRON will provide a script to identify which tables and values should be reviewed. In a few cases, some manual updates will need to be performed.

Manatron and the County will compare record counts between source and target databases for all migrated tables, and verify the presence of other needed schema objects in the target SQL Server database.

There will be some cases where Ascend stored SQL statements in the Informix database may not be valid on SQL Server. MANATRON will provide the proper translation for these syntax differences during the 1st migration. A script will then be provided to identify those rows with potentially invalid SQL statements may be created after the 1st migration pass which the County can use to identify syntax requiring manual update by the County.

Stored Procedure and User Defined Function Content. MANATRON will provide an inventory listing of all Ascend/ProVal related schema objects for County review to identify which tables should/should not be migrated during the 1st migration operation. MANATRON will provide SQL Server versions of stored procedure and user defined function content where appropriate. No procedures or functions will migrate directly from Informix to SQL Server. In some cases, jurisdiction specific procedures will need to be re-created for use on SQL Server.

Processes. Manatron and the County expect that Ascend and ProVal processes that function correctly on the Informix database will continue to function correctly on SQL Server. Since processes can be time sensitive, in terms of when they can be tested, we expect that processes needed for the cutover window will be tested by the county prior to going live on SQL Server. Any issues discovered with other non migration dependent processes after the post migration verification phase will be handled through normal customer support channels

Integration. We expect that the same integration channels, stored procedures, stored functions and touch point schema tables and other configuration currently in place between Ascend and ProVal will function equivalently on SQL Server.

Audit Tables, Triggers and Procedures. As a rule, audit table data can be migrated. The triggers and procedures will have to be re-created in Ascend, subsequent to the migration. MANATRON recommends that the legacy audit tables be archived and new audits reconfigured at migration time. The identification of the content of these tables will be provided during the 1st migration operation for the County to review. The County will be responsible for deciding which should be retained or dropped for migration.

Reports. MANATRON will provide core reports that will work correctly on SQL Server. State and County level reports will need to be reviewed and tested for modifications on the migrated system. MANATRON does provide a general translator for reports that are installed on the client workstations.

County Provided Resources

The county will provide the following resources for the Ascend/ProVal migration to SQL Server project:

1.) Test / Development Server Hardware and Software

The county will provide an adequate resource for the SQL Server database instance and migrated data. The Test/Development resource server should have these characteristics:

- a. 16 Gig Ram (4 Gig Minimum)
- b. 1 Socket multi-core processor per Test system (2 processors Minimum for Test Only)
- c. 350-500 Gig Minimum disk space per Test system
- d. Ethernet/Internet/Remote Desktop/or VPN connectivity
- e. Windows Server 2008 OS (64-bit recommended), 2008R2 acceptable
- f. SQL Server 2008 Standard Edition (64-bit recommended), 2008r2 acceptable in compatibility mode
- 2.) The Production server should have these characteristics:
 - a. 16 Gig Ram or better (8 Gig Minimum)
 - b. 1 Socket multi-core processor (4-core processors) or better
 - c. 500 Gig Minimum disk space or better
 - d. Ethernet/Internet//Remote Desktop/or VPN connectivity
 - e. Windows Server 2008 OS (64-bit recommended), 2008R2 acceptable
 - f. SQL Server 2008 Standard Edition (64-bit recommended), 2008r2 acceptable in compatibility mode
- 3.) Conversion Workstation Hardware and Software

A conversion workstation will need to be provided for purposes. Some or all of the hardware/software resources could be provided by the Test / Development Server if the county desires:

- a. 2 Gig Ram or better
- b. 2-core processor or better
- c. 1000 4000 Gig disk space
- d. Ethernet/Internet/Remote Desktop/or VPN connectivity
- e. Windows XP Professional OS or Windows 7 (32 bit) OS (with settings from bulletin)
- f. SQL Editor for Informix version 3.01 or better
- g. Cygwin (freeware)
- h. Textpad version 4.7.3 or better
- i. 7-zip (freeware)
- i. FTP access to Manatron site
- k. SQL Server 2008 Management Studio recommended, but 2008r2 okay

*(MANATRON can provide items f, g, h, i and assist with installation)

4.) Remote Desktop connectivity

- a. Remote desktop availability to the Test, Development, Production servers and Conversion workstation is required.
- b. Administrator or equivalent permissions to Test, Development, Production servers, and Conversion workstation are required. These can be restricted or possibly removed after cutover.
- c. SA account privileges to all SQL Server instances are required. These will be restricted or removed after cutover.

5.) Informix database availability

It is expected that the initial and first trial conversions will extract data from the county's test server, to minimize the impact to production processing. It would be best if the test data is a recent copy of the production data. MANATRON will do it's best to advise the county in advance of when the conversion trials will need to be run, and the test database refreshed from production.

6.) Data Cleansing

The conversion process will typically reveal certain data anomalies that will need to be addressed prior to the final conversion. Some items may be dealt with at conversion time, but others may best be addressed by manipulating the production data. The county may need to take some maintenance actions to accommodate these data cleansing needs.

7.) County Developed Processes and Schema objects

Any non-standard Ascend or ProVal schema objects including tables, views, triggers, stored procedures or other stored programs will be identified during the migration development, and the county will be advised of items that will not be part of the conversion. Some of these items may represent a significant investment of county time and resources to identify and ensure that critical business processes that may rely on some of these objects have been addressed.

8.) Web Servers and Ascend Service Processors

MANATRON will provide versions of our web and service products that will work with SQL Server hosted Ascend data. It will be the county's responsibility to provide adequate hardware, software, and analyst resources to install, configure, and test these products prior to cutover, and to make plans to install these new versions during or after cutover on production. Remote connectivity to these testing resources may be needed to support the installation, configuration and testing efforts by the county. eConvey and Personal Property eFile components have essentially been already adapted for SQL Server migration purposes. As a result, we do not expect significant work in those modules. The remaining module where a modest amount of work is expected would be with Ascend Web. The above Additional Conversions \$2,000 Not-to-Exceed Fee amount is for the required product engineer work to adapt/convert the Ascend Web feature to be compliant with the SQL Server platform.

9.) Client Workstation Resources

The recommended resources for Ascend/ProVal client installations are as follows: .

- a. 1 Gig Ram or better
- b. 2.2 Ghz Processor or better
- c. 500 Gig Disk or better [this reflects drives available for new purchases, as Querix is the only new software required on workstations, the legacy 160 Gig drives should be adequate}
- d. Ethernet connectivity to the Database Server
- e. Windows XP Professional
- f. Microsoft Access, Excel, Word 2003 or better

Manatron and County Responsibilities

1.) Conversion Scripts

Manatron will provide the conversion scripts to migrate the Informix data to unloaded text files. It is expected that Manatron will run the first trial, with the county participating, and that the county will run the second and final trials, with Manatron assistance where needed.

2.) Data Cleansing

Manatron will provide scripts and assistance for identifying data migration issues, and will train the county in the use of the scripts, and provide guidance and assistance for facilitating data cleansing efforts.

3.) Data Validation

Manatron will provide scripts and assistance for determining the completeness of the conversion data, and will provide guidance and assistance with troubleshooting any unexpected data migration issues.

4.) Template Schemas

Manatron will provide template schemas and any necessary configuration for enabling the respective applications on SQL Server.

5.) Security Configuration

Manatron will provide initial security configuration for accessing the migrated databases and applications, and will provide assistance and guidance to the county for the cutover security implementation.

6.) Updated Application Installation

Manatron will provide assistance for configuring and installing the SQL Server versions of their applications on the test platform, and will assist with creating scripts, registry files and installation instructions for the upgraded rollout. The county will perform the rollout to client workstations for additional user testing and final rollout before/during cutover.

7.) Migration Completion Assurance

Manatron will take responsibility to ensure that migrated versions of the applications and databases are working correctly in the customer's production environment.

8.) Non-Standard and Custom County Database Objects

The county will take responsibility for testing appropriate processes, integration, and any county developed processes or procedures that are not created or maintained by Manatron. Additionally, any custom County Ascend, ProVal or third party non-legislatively mandated reports or associated schema objects will need to be dealt with outside this agreement, and will not be addressed by these conversion methods unless other arrangements are made.

9.) Web Servers and Service Processes

The county will take responsibility for installing, configuring, testing and validating that any Ascend or ProVal web servers or processes are working correctly with the converted data, excluding any web data/functions for Ascend Web, Personal Property eFile, & eConvey (eREET). The county will take responsibility for cutover to SQL Server for these products and service processes as well.

10.) Account Detail Validations

The county will take responsibility for performing validations that account level details have been migrated completed and accurately. The county will have the responsibility to notify Manatron if they find issues with the converted data.

11.) Hardware, Software and Remote Connectivity Resources

The county will take the responsibility for ensuring that hardware and software and remote connectivity resources described County Provided Resources Section are provided or provisioned in a timely manner.

12.) Data Availability

The county will take responsibility to provide data for migration from the Informix database server at appropriate intervals for conversion trials, which will typically involve a refresh of the Informix test database from Production.

13.) Database and Application Versions

The county will take responsibility for ensuring the application versions are maintained in accordance with current procedures and migration plans so that target schema consistency on SQL Server can be maintained. During migration process, versions are to be maintained at agreed upon levels prior to the 1st migration operation. The County should apply the target version for each application (Ascend/ProVal) according to the version they want to have migrated. No version upgrades will be performed during the migration.

14.) Support Coordination

Manatron project contact will have responsibility for coordinating Support on conversion issues & ensuring immediacy in addressing those issues. A Communication Plan of conference calls on at least a weekly basis when needed if conversion or testing efforts are directly active or awaiting issue resolution to continue.

Based on County database usage, the anticipated 'best' cutover time identified at this time is either late February & early March, 2012 assuming contacting approval by end of August. To achieve this goal, this is the proposed timetable:

5.)	Sep 9, 2011	Test/Conversion machine resources and connectivity is available.
6.)	Sep 13, 2011	First Trial Conversion commences: DB configurations, Informix data unload, initial data manipulation, initial data load in new DBs, install/configure single Ascend & ProVal client against migration DB & train County DIS.
7.)	Sep 15, 2011	First Trial Conversion application connectivity and testing begins. Milestone 2 with successful testing started.
8.)	Oct 13, 2011	Review First Trial Conversion and plan Second Trial.
9.)	Oct 14, 2011	Schedule refresh of Test from Production.
10.)	Oct 17, 2011	Second Trial Conversion commences- County primary/Manatron support.
11.)	Oct 19, 2011	Second Trial Conversion application connectivity and testing begins.
12)	Oct 24, 2011	Testing of Report and Processes commences.
12.)	Oct 31, 2011	Testing of Web Products and services commences.
13.)	Nov 3, 2011	Review of Second Trial Conversion and Plan Cutover.
14.)	Nov 4, 2011	Plan for Third Trial if desired.
15.)	Feb 1, 2012	Plan for Final Conversion.
16.)	Feb 20, 2012	Final Conversion commences for production cutover – final creation & configuration of Ascend/ProVal SQL Server test DB, final Informix data unload, data manipulation, & load of converted SQL Server data into new SQL Server db.

18.)	Feb 27, 2012	SQL Server Activation of Production. Milestone 3 with successful cutover/rollout.

This timeline is suggested as a starting point for planning discussions. It is preferable to have the first two trials done as early as possible, leaving time for a potential third conversion trial if needed, or for additional process/testing time.
